## DECLARATION OF HIGHEST RATED AND RESPONSIVE BID (HRRB)

## Consulting Services for the Enhancement and Implementation of the Build Build (BBB) Portal

WHEREAS, pursuant to BAC-C Resolution No. BC-2018-011 dated April 16, 2018, the Bids and Awards Committee for Consulting Services (BAC-C) declared **Technovore Systems, Inc. (Technovore)** as the bidder with the Highest Rated Bid (HRB) for the procurement of Consulting Services for the Enhancement and Implementation of the BBB Portal;

WHEREAS, the same resolution resolved to recommend the approval to proceed with the negotiation with Technovore;

WHEREAS, the project has an Approved Budget for the Contract (ABC) in the amount of Pesos: Four Million Four Hundred Seven Thousand Five Hundred Fifty and 00/100 (Php4,407,550.00), inclusive of all applicable taxes and fees to be completed within nine (9) months;

WHEREAS, the evaluation procedure adopted in the procurement was the Quality Cost Based Evaluation (QCBE) System, wherein the technical and financial proposals were given numerical weights equivalent to 75% and 25%, respectively;

WHEREAS, after the conduct of negotiations on May 8, 2018, the Technical Working Group (TWG) was instructed to conduct the post-qualification activities to verify, validate and ascertain all statements made and documents submitted by Technovore;

WHEREAS, the TWG conducted the following post qualification activities on May 9, 2018:

- 1. Ocular visit to the office of Technovore located at 19F Marco Polo Ortigas Manila, Sapphire Road, Ortigas Center, Pasig City;
- 2. Validation of the original copies of the following documents:
  - a. PhilGEPS Registration Certificate under Platinum Category
  - b. Class "A" Legal Documents
  - c. Original documents in compliance to labor law such as latest payment to SSS, PhilHealth and Pag-ibig Fund
  - d. Supporting documents for completed and on-going contracts;
- 3. Conduct of interview with the key personnel to validate their technical competence, experience and capabilities as indicated in their respective Curriculum Vitae; and
- 4. Performance verification in the delivery of services, through phone calls, with their previous and current clients;

**NOW THEREFORE**, after deliberation and premises considered, we, the members of the BAC-C hereby RESOLVE to recommend the approval of the following:
