## DECLARATION OF THE BIDDER WITH THE HIGHEST RATED BID (HRB)

## Consulting Services for the Enhancement and Implementation of the **Build Build Portal**

WHEREAS, a Memorandum of Agreement (MOA) was executed among the Department of Finance (DOF), Department of Public Works and Highways (DPWH), Department of Transportation (DOTr), Department of Budget and Management (DBM), National Economic and Development Authority (NEDA), and Bases Conversion and Development Authority (BCDA) for the creation of the inter-agency Build Build Build Core Committee (BBB-CC), "Annex A";

WHEREAS, pursuant to the authority granted in the MOA, BCDA conducted the procurement of the Consulting Services for the Enhancement and Implementation of the BBB Portal;

WHEREAS, the Approved Budget for the Contract (ABC) is Pesos: Four Million Four Hundred Seven Thousand Five Hundred Fifty and 00/100 (Php 4,407,550.00), inclusive of all applicable taxes and fees;

WHEREAS, on November 11, 2017, BCDA advertised the Request for Expression of Interest (REI) for said consulting services in the BCDA website, PhilGEPS and in a conspicuous place in the premises of BCDA, continuously for seven (7) days;

WHEREAS, in response to the advertisement, TELCOM LIVE CONTENT, INC. (Telcom) and TECHNOVORE SYSTEMS, INC. (Technovore) submitted their Eligibility Documents, wherein both proponents passed the Eligibility Check;

WHEREAS, on December 6, 2017, BAC-C issued Resolution No. BC-2017-047, declaring Telcom and Technovore as shortlisted, having garnered a total score above the required minimum score of 70% and proceeded to the next bidding activity detailed as follows:

WHEREAS, the proponents submitted their Technical and Financial Proposals before the deadline on December 27, 2017, 8:00 am;

**WHEREAS**, the Technical and Financial Proposals were opened on January 8, 2018 and January 16, 2018, respectively. The proponents were also required to make an oral presentation of their plans and methodology on January 16, 2018;

WHEREAS, the evaluation procedure adopted is Quality-Cost Based Evaluation (QCBE), with a corresponding weight of 75% and 25% for the Technical and Financial Proposals. Only the bidder whose technical proposal meets the minimum technical score of 70% shall be allowed to proceed with the opening of the financial proposal;

WHEREAS, based on the evaluation, the bidders' technical and financial proposals were found to be compliant, the summary of the results are as follows:
