BID BULLETIN NO. 11

The BAC-C hereby issues the Bidding Documents and Bidding Forms for the Bidding for the Consulting Services for the Detailed Architectural and Engineering Design of the Second Runway Infrastructure Project of the Clark International Airport (CIA), and clarifies matters relating to the project:

2. Submission of the Foreign Professionals' equivalent License issued by their country of origin

The Shortlisted Bidders are required to submit the <u>equivalent</u> licenses of their nominated foreign key personnel, as proof of their profession, issued by the country of origin of the foreign key personnel during the submission of bids.

The PRC Licenses/Special Temporary Permits (STPs) of the foreign key personnel are required within ten (10) days from receipt by the winning bidder of the Notice of Award pursuant to Section 37.1.4(a)(iii) of the Revised IRR of RA 9184 which provides:

"Within ten (10) days from receipt by the winning bidder of the Notice of Award, the following conditions should be complied before the contract may be awarded:

a) Submission of the following documents within ten (10) calendar days from Notice of Award:

iii) The SEC Certificate of Registration of the foreign corporation, or the SEC Certificate of Registration of the foreign consulting firm, and/or **the authority or license from the appropriate government agency or professional regulatory body of the foreign professionals engaging in the practice of regulated professions and allied professions, where applicable."**

In view of the above-mentioned provision of IRR of R.A. 9184, the bidders are required to submit a Letter of Undertaking during the submission of bids. Attached is the format of the Letter of Undertaking.

Subject: LETTER OF UNDERTAKING

Dear BAC-C Chairperson:

In relation to our participation in the bidding for the Consultancy Services for the Detailed Architectural and Engineering Design of the Second Runway Infrastructure Project of the Clark International Airport, I (<u>Name</u>) in my capacity as the Authorized Representative/Managing Officer of the (<u>name of Firm, Partnership, Corporation or Joint Venture</u>), do hereby undertake to submit the authority to practice profession of our foreign nominated key personnel from the Professional Regulation Commission (PRC) within ten (10) days from receipt of the Notice of Award or within the period set by the BAC-C, in the event that the project is awarded to us, pursuant to Section 37.1.4(a)(iii) of the Revised IRR of RA 9184 which provides:

- "37.1.4 Within ten (10) days from receipt of by the winning bidder of the Notice of Award, the following conditions should be complied before the contract may be awarded:
 - a) Submission of the following documents within ten (10) calendar days from Notice of Award:
 - *iii) The SEC Certificate of Registration of the foreign corporation, or the SEC Certificate of Registration of the foreign consulting firm, and/or the authority or license from the appropriate government agency or professional regulatory body of the foreign professionals engaging in the practice of regulated professions and allied professions, where applicable."*

If we fail to submit the authority to practice profession of our foreign nominated key personnel from the PRC within the period allowed above, we understand that our (<u>Firm, Partnership, Corporation or Joint Venture</u>), will be disqualified as bidder, pursuant to Section 40.2 of the Revised IRR of RA 9184 which provides:

"40.2 In the case of the failure, refusal or inability of the bidder with LCRB or HRRB to submit the documents required under Section 37.1 of this IRR or to enter into contract and post the required Performance Security, as provided in this Section, the BAC shall disqualify the said bidder, and shall initiate and complete the post- qualification process on the bidder with the second Lowest Calculated Bid/Highest Rated Bid: Xxx."

We understand that disqualification is the only consequence of such failure to submit the authority to practice profession of our foreign nominated key personnel from the PRC within the period allowed above and no other sanction or penalty shall be imposed on such failure.
