The BAC-C of BCDA, in line with the guidelines of the Department of Health and pronouncement of National Government, would like to ensure that preventive efforts and measures are observed during the **Opening of Financial Proposals** for the above-mentioned project **on 01 March 2022 at 1:00 PM**. The bidders or their representatives are advised of the following arrangements during the said activity:

1. The bidders/representatives who will opt to attend the Opening of Financial Proposals in-person shall be guided to the BCDA Lobby Hall at BCDA Corporate Center, 2/F Bonifacio Technology Center, Bonifacio Global City, Taguig City. In view of the pronouncement of the National Government on the downgrading of the National Capital Region (NCR) to Alert Level 1 effective 01 March 2022, **two (2) representative/s** of each bidder are allowed to attend and witness the proceedings of the said opening.
2. The bidders/representatives shall be **required** to present their **vaccination cards/certificates** or their **negative RT-PCR test results valid within 72 hours** prior to entry at the BCDA office/premises.
3. The bidders/representatives should download the StaySafe Application and register prior to entry at the BCDA office/premises.
4. The bidders/representatives shall individually scan their temperature at the BCDA office entrance. A **bidder/representative with a temperature of 37.5°C or above shall not be allowed to enter the BCDA premises**. If the temperature is below 37.5°C, the bidder/representative should scan the QR code provided at the entrance of the BCDA office.
5. The bidders/representatives with flu-like symptoms and with travel history from outside of the Philippines for the last three (3) weeks are advised not to attend in person at the venue of the Opening of Financial Proposal.
6. The bidders/representatives shall wear their face masks, and maintain social distancing throughout the Opening of Financial Proposals.

7. Finally, bidders/representatives shall bring their own ball pen for purposes of signing their attendance in the meeting.

### **Provision of Video Conference Platform**

Pursuant to the pronouncement of the National Government on Alert Level guidelines, the BCDA strictly limits the entry of people in its premises.
