## PROCUREMENT OF CONSULTING SERVICES FOR THE CONDUCT OF THE BCDA 2023 PLANNING SESSIONS (Declaration of Failure of Bidding)

## **RESOLUTION NO. 2022-023**

WHEREAS, on 02 December 2022, the BAC-C issued BAC-C Resolution No. 2022-019 recommending the procurement of consulting services for the conduct of 2023 BCDA Planning Sessions through Negotiated Procurement – Small Value Procurement under Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184;

**WHEREAS**, in the same resolution, the BAC-C delegated the procurement to the Corporate Planning Department of BCDA, the end-user and proponent of the consulting service;

**WHEREAS**, on 08 December 2022, BCDA advertised the Request for Proposal (RFP) for the consulting service in the BCDA website, PhilGEPS website and in a conspicuous place in the premises of BCDA continuously for three (3) calendar days;

**WHEREAS**, the end-user reported that no bids were received on the deadline for submission of proposal on 13 December 2022, 3:00 PM;

**WHEREAS**, the end-user, on its memorandum dated 15 December 2022, declared the failure of bidding and requested for reposting of the RFP, Terms of Reference (TOR) and bidding documents;

**WHEREAS**, on 18 December 2022, the RFP, TOR and bidding documents were reposted on the BCDA and PhilGEPS websites, providing 26 December 2022 as the deadline of submission of proposals. Due to Proclamation No. 115, additional special non-working holidays were declared thus the deadlines for submission and opening of bids were moved to 27 December 2022 at 10:00 A.M. and 11:00 A.M. ;

WHEREAS, two (2) firms submitted their proposals, to wit:

**WHEREAS**, the Eligibility Documents, Technical Proposal and Financial Proposal of Career Clinic & Enterprise Solutions, Inc. were opened on 27 December 2022 at 11:00 AM. Meanwhile, the bid of People Dynamics, Inc. was not accepted and returned on the same day to the bidder due to the late submission of the proposal;

**WHEREAS**, the end-user conducted a collegial evaluation of the Eligibility Documents, Technical Proposal and Financial Proposals based on the approved criteria using the Quality-Based Evaluation (QBE) procedure;

**WHEREAS**, the detailed evaluation of the technical proposal of Career Clinic & Enterprise Solutions, Inc. is rated "FAILED" due to non-compliance with the requirements of the Technical Proposal, specifically for not meeting the required minimum score for Criterion I. Applicable Experience of the Consultant which resulted in an overall score of 69%, as shown in the table below:

WHEREAS, the evaluation of the financial proposal showed that the submission was non-compliant as it exceeded the Approved Budget for the Contract (ABC) of **Pesos: One Million and 00/100 (PhP 1,000,000.00)**, inclusive of VAT and all applicable taxes, fees and incidental expenses:

WHEREAS, based on the above-detailed evaluation, Career Clinic & Enterprise Solutions, Inc. is declared "FAILED" and "INELIGIBLE" due to non-compliance with the requirements provided under the Eligibility Documents and Terms of Reference (TOR) for the consulting services, and 2016 RIRR of RA 9184.

**WHEREAS**, the end-user in its memo to the BAC-C dated 27 December 2022 requested the declaration of failure of bidding and termination of the bidding process of the Procurement of Consulting Services for the Conduct of 2023 BCDA Planning Sessions;

**NOW, THEREFORE**, foregoing considered, We, the Members of the Bids and Awards Committee for Consulting Services, hereby RESOLVE as it is hereby RESOLVED, to:
