The BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the CY 2022 General Appropriations Act (GAA), has undertaken the Procurement of the **Operation and Maintenance of the New Clark City Sports Facilities: Supply, Delivery, and Installation of Furniture, Appliances, Linens and Hardware and Accessories for the National Government Administrative Center Sports Facilities - Lot 2 (Appliances)** with an Approved Budget for the Contract (ABC) of Pesos: **Three Million Five Hundred Twelve Thousand Three Hundred Twenty Pesos and 00/100 (Php 3,512,320.00)**, inclusive of VAT and all other applicable government taxes and fees;

WHEREAS, the Bids and Awards Committee for Goods (BAC-G), advertised/posted the Invitation to Bid including the bidding documents on 20 October 2022 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, the BAC-G conducted a Pre-bid Conference on 7 November 2022, which was attended by one (1) prospective bidder, **Tarlac Mac Enterprises, Inc.**;

WHEREAS, in response to the said Invitation, **Tarlac Mac Enterprises, Inc.** submitted its bid prior to the deadline for the submission of bids;

WHEREAS, during the Opening of Bids on 25 November 2022 at 1:00 PM, the BAC-G declared the technical proposal of **Tarlac Mac Enterprises, Inc.** as "passed";

WHEREAS, after evaluating the eligibility and technical documents of **Tarlac Mac Enterprises, Inc.**, the BAC-G, through its Technical Working Group, thereafter opened its financial proposal and noted the following :

WHEREAS, on 30 November 2022, the BAC-G Technical Working Group conducted a detailed evaluation of **Tarlac Mac Enterprises, Inc.**'s bid. In view of the results of the Detailed Evaluation of Bids, the BAC-G has declared the bid of **Tarlac Mac Enterprises, Inc.** as eligible;

WHEREAS, the BAC-G recommended that **Tarlac Mac Enterprises, Inc.** undergo a post qualification pursuant to Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act 9184;

WHEREAS, BAC-G deliberated on the results of the post-qualification and found that **Tarlac Mac Enterprises, Inc.** is eligible, legally, technically, and financially capable to undertake the project;

NOW, THEREFORE, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

To declare **Tarlac Mac Enterprises, Inc.** as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of the **Operation and Maintenance of the New Clark City Sports Facilities: Supply, Delivery, and Installation of Furniture, Appliances, Linens and Hardware and Accessories for the National Government Administrative Center Sports Facilities - Lot 2 (Appliances)**, and to award the contract in the amount of Pesos: **Three Million Four Hundred Seventy-Seven Thousand and Five Hundred Fifty-Five and 00/100 (Php3,477,555.00)**, inclusive of VAT and all applicable taxes and fees.
2. To direct the Property and Procurement Management Department (PPMD), as the end-user unit, to submit to the BAC-G the duly confirmed Notice of Award, Notice to Proceed, and a signed agreement/contract within the prescribed period.
