Queries/Questions	Clarifications / Responses
Q1. DUPA requirement In Bid Bulletin no. 4 and in the bidding documents we noticed inconsistencies on the issue of the Detailed Unit Price Analysis (DUPA). The Financial Component Envelope indicated in the Bid documents mentioned the inclusion of Duly accomplished Detailed Cost Estimates. However, the reply on Q19 in the Bid Bulletin no. 4 say "DUPA is not required in the Bid Submission. However, it should be submitted to BCDA within one month after the issuance of the Notice to Proceed (NTP) to the winning bidder." In this regard, may we request clarifications.	Detailed Unit Price Analysis (DUPA) is different with the Detailed Cost Estimates (DCE). For the DCE, this form should be included in the Financial Component envelope pursuant to Clause 11.1 of the Bid Data Sheet (BDS), which states that: <i>"In addition to the Bid Form and Bill of Quantities, the following <u>shall be</u> <u>included in the Financial</u> <u>Component</u>: 1. Detailed Cost Estimates prescribed in 'Annex P'"</i>

Please refer to Section I , Item I of Bid Bulletin No.5 for the amendment of the Checklist of Technical Component Envelope.
Q3.	Format of Curriculum Vitae For the format of the Curriculum Vitae, If a proposed key Technical Personnel is not an employee, do we have to fill out the "Current Position in the firm" and "years with the firm", put N/A, or leave it blank?	If a proposed key personnel is not an employee, state 'Not Applicable' in the field of 'Current Position in the Firm' and 'Years with Firm/Entity'. In addition, per Item 3 of the BDS Clause 10.4, the said key personnel shall submit a Certification duly signed by him/her that he/she will work for the bidder if the latter is awarded the contract for the project.

Q4.	Definition of JV Please provide definition of "existing JV" and "potential JV".	An <u>existing joint venture</u> is a partnership that is already established and has a valid joint venture agreement (JVA)
		On the other hand, a <u>potential joint</u> <u>venture</u> refers to a proposed partnership that has not yet been established and will enter into a JVA in case they win the bid.


