- b. A maximum of two (2) representatives, including the driver, per prospective bidder, are allowed to join the site inspection. For joint ventures/consortiums, only one (1) representative per each firm is allowed to join the site inspection.
- c. Attendance must be confirmed with the Secretariat, through the email address **bacisec@bcda.gov.ph**, not later than 5:00 PM on **06 July 2023 (Thursday)**. Please provide a scanned copy of the representative's ID and Vaccination Cards; and plate number of the vehicle; and
- d. Face masks must be worn at all times and social distancing must be observed throughout the site visit/inspection.
