WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the PROCUREMENT OF I.T. WHEREAS, on 29 May 2017, the Technical Working Group (TWG) conducted post-qualification of the three (3) eligible bidders to determine whether they comply with and are responsive to the requirements and conditions specified in the Bidding Documents; and after careful examination, validation and verification of all the eligibility, legal, technical and financial documents submitted to the BAC-G, the TWG recommended in its Post-Qualification Report (hereto attached as Annex B) to post-disqualify MCSA for Lots F, H, and I due to non-compliance with the Technical Specifications; and, further recommended to award the following lots to the respective bidder/s found Complying and Responsive:
