**RESOLUTION NO. BG-2017-043**

**WHEREAS**, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the **Procurement of BCDA Surveying Equipment** with an Approved Budget for the Contract (ABC) in the amount of **Pesos: Nine Million Three Hundred Forty Four Thousand Three Hundred Twenty Five (PhP9,344,325.00)**, inclusive of all applicable taxes and fees, with breakdown as follows:

**WHEREAS**, the BAC-G, through its Secretariat, posted the Invitation to Bid (IB) on 30 November 2017 in the DBM Philippine Government Electronic Procurement System (PhilGEPS) website, BCDA website, and in a conspicuous place reserved for the purpose in the premises of BCDA;

**WHEREAS**, in response to the posted IB, *Certeza Infosys Corporation* bought the bidding documents;

**WHEREAS**, on the scheduled Opening of Bids, BAC-G received a lone proposal which was from *Certeza Infosys Corporation*;

**WHEREAS**, during the Opening of Bids held on 20 December 2017, the lone participating bidder, having submitted the required eligibility documents, was found to be "eligible", thus, the financial proposal was opened;

**WHEREAS**, the lone "eligible" bidder submitted the bid for the **Procurement of BCDA Surveying Equipment** in the total amount of **Php9,344,000.00** for Lots A & B, inclusive of all applicable taxes and fees; the Abstract of Bid and the TWG's Bid Evaluation Report are hereto attached as **Annex "A"** and made an integral part of this Resolution;

**WHEREAS**, on 27 December 2017, the Technical Working Group (TWG) conducted post-qualification of the bidder with Single Calculated Bid (SCB) to determine whether it complies with and is responsive to the requirements and conditions specified in the Bidding Documents; and after careful examination, validation and verification of all the eligibility, legal, technical and financial documents submitted to the BAC-G, the TWG recommended in its Post-Qualification Report (hereto attached as **Annex "B"**) to award the contract to *Certeza Infosys Corporation*, who was found Complying and Responsive;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the following:

1. To declare **Certeza Infosys Corporation** as the bidder with the Single Calculated and Responsive Bid (SCRB) for the **Procurement of BCDA Surveying Equipment**;
2. To award the Contract to **Certeza Infosys Corporation** in the amount of **Pesos: Nine Million Three Hundred Forty Four Thousand (Php9,344,000.00)** inclusive of all applicable taxes and fees;
3. To issue the corresponding Notice of Award (NOA) **Certeza Infosys Corporation**.
