## Re-Bidding of Security Services for AOR III – Bataan Technology Park, Morong, Bataan

## RESOLUTION NO. BG 2017-036

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on re-bid, after a failure of bidding in 2016, the procurement of Security Services for Area of Responsibility (AOR) III – Bataan Technology Park (BTP) for a three (3)-year term, with an Approved Budget for the Contract (ABC) of Seven Million Four Hundred Forty One Thousand One Hundred Forty Pesos (PhP7,441,140.00) for the first year, inclusive of all applicable taxes and fees, with breakdown as follows:

**WHEREAS**, the BACG, through its Secretariat, posted on 18 August 2017 the Invitation to Bid in the PhilGEPS and BCDA websites, and in a conspicuous place reserved for the purpose in the premises of BCDA, for seven (7) calendar days;

**WHEREAS**, in the Pre-bid Conference held on 31 August 2017, clarifications and queries raised on the bidding documents were discussed, and thereafter, *Bid Bulletin No. SSB-2017-001* was issued, a copy of which is hereto attached as **Annex "A"**;

**WHEREAS**, in response to the posted Invitation to Bid, only *Baguio's Finest Security Agency (BFSA)* bought the bid documents and eventually submitted its bid/proposal;

**WHEREAS**, during the Opening of Bids held on 15 September 2017, BFSA, having submitted the required eligibility documents, was found to be "eligible", thus, its financial proposal was opened;

**WHEREAS**, the lone "eligible" bidder submitted the bid for the Security Services for AOR III – BTP in the amount of **Php7,273,809.60** inclusive of all applicable taxes and fees; the Abstract of Bid is hereto attached as **Annex "B"**;

WHEREAS, on 21-22 September 2017 the Technical Working Group (TWG) conducted post qualification on BFSA to determine whether it complies with, and is responsive to the requirements and conditions specified in the Bidding Documents; and after careful examination, validation and verification of all the eligibility, technical and financial documents submitted to the BACG by BFSA, its bid has been found Complying and Responsive; the Post Qualification Report is hereto attached as **Annex "C"**;
