TO ALL PROSPECTIVE PRIVATE SECTOR PARTICIPANTS:

This Bid Bulletin No. 8 is being issued to clarify the Invitation Documents for the Competitive Selection for the Joint Venture Development of the Water and Wastewater Infrastructure Project in New Clark City (the "**Project**").

Capitalized terms used and not otherwise defined in this Bid Bulletin No. 8 shall have the meaning given to them in the Instructions to Private Sector Participants ("**IPSP**"): Volume 1 - Eligibility Documents relating to the Project issued by the Joint Venture Selection Committee of the Bases Conversion and Development Authority for the Project, as amended.

A. Amendment of Eligibility Documents Submission Date and Opening of Eligibility Documents

This Bid Bulletin No. 8 is being issued to inform all prospective private sector participants that:

1. **9 July 2018 at 9:00 a.m.** shall (as an amendment of the date previously indicated as 2 July 2018 at 12:00 p.m.) be the date of Eligibility Documents Submission Date. Section 8 of IPSP: Volume 1 – Eligibility Documents is accordingly modified to reflect such date and time.
2. **9 July 2018 at 9:30 a.m.** shall (as an amendment of the date previously indicated as 2 July 2018 at 2:00 p.m.) be the date of opening of Eligibility Documents. Sections 7.4(e) and 11.1 of IPSP: Volume 1 – Eligibility Documents are accordingly modified to reflect such date and time.

In consideration of the nature and scope of the Project, the foregoing modification has been approved by the JVSC to provide prospective private sector participants additional time to evaluate the Eligibility Requirements and complete their Eligibility Documents pursuant to the principles of competition and fairness.

B. Eligibility Evaluation Checklist

Attached as Annex "A" is the Eligibility Documents Checklist which provides a guide for prospective private sector participants in the completion and submission of the Eligibility Documents.

The information contained in the Eligibility Documents Checklist constitutes BCDA Supplied Information and therefore no reliance can be made on this BCDA Supplied Information. The information therein is provided to the prospective private sector participants on the same terms and conditions set out in the IPSP: Volume 1 – Eligibility Documents. In the event of a conflict or discrepancy between the Eligibility Documents Checklist and the IPSP: Volume 1 – Eligibility Documents, the latter shall prevail.

No terms of the IPSP: Volume 1 – Eligibility Documents are modified by the Eligibility Documents Checklist.

In accordance with Section 2.3 of the IPSP: Volume 1 — Eligibility Documents, this Bid Bulletin No. 8 is issued to all parties who purchased the IPSP: Volume 1 – Forms and Annexures.
