The Bases Conversion and Development Authority (BCDA) hereby awards the contract for **Health Care Service Provider** to **Philippine British Assurance Company, Inc. - 2. Post a Performance Security denominated in Philippine Pesos in the form and in the amount stipulated in Section 39.2 of the revised IRR of RA 9184 which shall be posted in favor of BCDA and which shall remain valid until the issuance of Certificate of Final Acceptance.
