**RENOVATION OF THE CLARK INTERNATIONAL AIRPORT (CIAC) DOMESTIC
ARRIVAL FAÇADE AND HALLWAY AND CONSTRUCTION OF CONNECTING
GANGWAY BETWEEN THE TWO PRE-DEPARTURE AREAS**

WHEREAS, the Bases Conversion and Development Authority (BCDA), through the Project Management Department (PMD) intends to undertake the renovation of the Clark International Airport Domestic Arrival Façade and Hallway and Construction of Connecting Bridge between the two Pre-Departure areas.

WHEREAS, in a memo dated 22 October 2018, President and CEO approved the Program of Works (POW), budget and detailed plans for the procurement of hardware materials for the renovation of the Clark International Airport Domestic Arrival Façade and Hallway and Construction of Connecting Bridge between the two Pre-Departure areas.

WHEREAS, the renovation and construction has an approved budget amounting to Pesos: Five Million Four Hundred Ninety Thousand Four Hundred Twenty Six and 00/100 (PhP5, 490, 426.00).

WHEREAS, in the anticipation of the influx of passengers in the upcoming yuletide season, there is a need to provide swing gates that will address the congestion within the pre-departure area and to renovate the existing Domestic Arrival Façade and hallway for it was simply built with dry walls and painted cement floor.

WHEREAS, in a letter dated 12 November 2018, Clark International Airport Corporation (CIAC) gave no objections to BCDA in providing the budget and undertaking the said renovation and construction at the Clark International Airport terminal.

WHEREAS, Item 3.2 Section 3 of Appendix 1 "Revised Guidelines for the Implementation of Infrastructure Projects By Administration" of the RA 9184 provides that:

"3.2 To undertake projects by administration, the implementing agency must:

- a. *have a track record of having completed, or supervised a project, by administration or by contract, similar to and with a cost of at least fifty percent (50%) of the project at hand."*

WHEREAS, BCDA has previously undertaken procurement by administration in other projects such as the Construction of the Clark Green City Field Office in Capas, Tarlac which amounts to PhP 4,301,796.73.

WHEREAS, Item 3.4 and 3.5 Section 3 of Appendix 1 “Revised Guidelines for the Implementation of Infrastructure Projects By Administration” of the RA 9184 provides that:

“3.4 No contractor shall be used by the procuring entity, directly or indirectly for works undertaken by administration.

3.5 Procurement of tools and construction equipment shall be subject to the rules on public bidding.”

WHEREAS, based on the representations of the PMD, the following applicable conditions for renovation by administration and supervision by the BCDA are complied with:

1. Due to the urgency of the project to be undertaken, the implementation is intended to be carried out under administration and supervision of BCDA. Additional skilled manpower shall be hired in accordance with Section 3 Conditions and Requirements for the use of “By Administration” Appendix 1 of the RA 9184 to fast track the said implementation.
2. The construction materials, rental of equipment, and additional skilled manpower, as needed, shall be procured by Procurement and Property Management Department (PPMD) Section 3 Conditions and Requirements for the use of “By Administration” Appendix 1 of the RA 9184.

NOW, THEREFORE, foregoing premises considered, we, the Members of the BAC for Goods hereby **RESOLVE**, as it is hereby resolved, to recommend the implementation of the project by administration of BCDA through PMD and to authorize PPMD to undertake the procurement of the needed materials, labor, and rental of equipment, if any, in accordance with Appendix 1 “Revised Guidelines for the Implementation of Infrastructure Projects By Administration” of the RA 9184.
