DECLARATION OF THE BIDDER WITH THE HIGHEST RATED BID (HRB)

**Consulting Services for Construction Management and Supervision of the Airport
(CIA) to New Clark City (NCC) Access Road**

WHEREAS, on May 21, 2018, BCDA advertised the Request for Expression of Interest (REI) for the said consulting services in the BCDA website, PhilGEPS and in conspicuous place in the premises of BCDA continuously for seven (7) calendar days;

WHEREAS, the consulting services has an Approved Budget for the Contract (ABC) amounting to **Pesos: One Hundred Seventeen Million and 00/100 Pesos (PhP 117,000,000.00)**, inclusive of all applicable taxes, fees and other charges, to be completed within 18 months for the construction phase and three (3) months for the post construction / documentation phase;

WHEREAS, on June 21, 2018, the Bids and Awards Committee for Consulting Services (BAC-C) issued BAC-C Resolution No. BC-2018-025 declaring the following bidders as **SHORTLISTED** and **ELIGIBLE** to proceed to the next stage of the bidding process:

- a. Design Science, Inc.
- b. Joint Venture of Filipinas Dravo Corp. & Pertconsult International
- c. Joint Venture of DCCD Engineering Corporation / Katahira & Engineers Intenational

WHEREAS, the evaluation procedure adopted to be declared as the bidder with the Highest Rated Bid (HRB) was the Quality-Cost Based Evaluation (QCBE) procedure, wherein the technical and financial proposals were given a corresponding weight of 85% and 15%, respectively. The consultant must pass the required 70% minimum score;

WHEREAS, the abovementioned consulting firms submitted their Technical and Financial Proposals before the deadline of submission of bids on July 23, 2018 at 9:00 AM;

WHEREAS, on July 23, 2018 at 9:30 AM, the technical proposals were opened and evaluated based on the approved detailed evaluation criteria where the required minimum score is 70%. The results are as follows:

WHEREAS, on August 28, 2018, the BAC-C proceeded with the opening of financial proposals of bidders who passed the required minimum score for technical proposal of 70%;

WHEREAS, all financial bids were found to be within the ABC;

WHEREAS, the results of the combined Technical & Financial evaluation and ranking of the bidders are as follows:


