

**BAC-C RESOLUTION BC-2019-012**

**CONSULTANCY SERVICE FOR THE MAINTENANCE, LICENSING, CLOUD  
HOSTING AND OPERATIONS OF THE BUILD BUILD BUILD PORTAL**

**DECLARATION OF CANCELLATION OF BIDDING**

**WHEREAS**, on 19 March 2019, BCDA advertised the Request for Expression of Interest (REI) for the Consultancy Service for the Maintenance, Licensing, Cloud Hosting and Operations of the Build Build Build (BBB) Portal in the BCDA website, PhilGEPS website and in a conspicuous place in the premises of BCDA continuously for seven (7) calendar days;

**WHEREAS**, the procurement for the above services has an Approved Budget for the Contract (ABC) amounting to Pesos: Four Million Six Hundred Thousand and 00/100 (Php4,600,000.00), inclusive of all applicable taxes and fees for a period of one (1) year and an additional one (1) month of warranty support;

**WHEREAS**, the procurement of the said services shall be undertaken through competitive bidding using Quality-Cost Based Evaluation (QCBE) procedure wherein the Technical and Financial Proposals shall be given corresponding weights;

**WHEREAS**, on 26 March 2019, a Pre-eligibility Conference was held and attended by representatives of several prospective bidders;

**WHEREAS**, on 08 April 2019, Telcom Live Content, Inc. submitted its eligibility documents before the deadline for submission of eligibility documents on April 12, 2019;

**WHEREAS**, on 16 April 2019, the Executive Vice President (EVP) of BCDA, upon request of the Task Force Head for the BBB Portal, approved the request to terminate the on-going procurement, the revised Terms of Reference and increased budget for the rebidding of the project;

**WHEREAS**, in a memo dated 17 April 2019, the Head of the Task Force for the BBB Portal requested the BAC-C for the termination of the on-going procurement due to changes in the scope of works and to start a new bidding process;

**WHEREAS**, the Approved Budget of the Contract for the rebidding will be increased from Four Million Six Hundred Thousand Pesos (Php4,600,000.00) to Six Million Pesos (Php6,000,000.00);

**WHEREAS**, in the revised scope of works, the Consultant shall be required to utilize the existing cloud hosting instead of giving the option to either use the existing or provide a new cloud hosting. This will ensure that the portal is continuously running and will prevent downtime in case of transition;

**WHEREAS**, the revised scope of works will require a minimum of 25 licenses instead of the proposed 12 licenses;

**WHEREAS**, Section 41.C, Reservation Clause of the Revised IRR of RA 9184 provides that the Head of Procuring Entity (HoPE) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract for any justifiable and reasonable ground where the award of the contract will not redound to the benefit of the Government of the Philippines (GoP), as follows: (i) if the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the HoPE; xxx

**WHEREAS**, the modifications in the scope of works are deemed significant changes and proceeding with the on-going procurement is not technically feasible, hence, will not redound to the benefit of the GoP;

**NOW, THEREFORE**, we, the members of the Bids and Awards Committee for Consulting Services, hereby RESOLVE, as it is hereby RESOLVED to:

1. DECLARE and ISSUE a Notice of Cancellation of Bidding for the Consultancy Service for the Maintenance, Licensing, Cloud Hosting and Operations of the BBB Portal based on Section 41.C of the Revised IRR of RA 9184;
2. DIRECT the end user to conduct a mandatory review of the other provisions of the TOR and other bid documents and submit to BAC-C the revised TOR and eligibility documents;
3. RETURN the eligibility documents of Telcom Live Content, Inc. unopened.
