CONTRACT AGREEMENT FOR THE OPERATIONS AND MAINTENANCE OF **NEW CLARK CITY (NCC) ACCESS ROADS (ESTATE MANAGEMENT)**

This **AGREEMENT** made the ____ day of 2024 between BASES CONVERSION AND DEVELOPMENT AUTHORITY of the Philippines, a government instrumentality vested with corporate powers, created by virtue of Republic Act No. 7227, as amended, with principal office address at the BCDA Corporate Center, 2nd Floor Bonifacio Technology Center, 31st corner 2nd Avenue, Bonifacio Global City, Taguig City, represented herein by its President and CEO, **JOSHUA M. BINGCANG**, hereinafter called **"the Entity"**; of the one part and BGC PHILBUILDER INC., a private entity duly organized and existing under the laws of the Republic of the Philippines, with office address, Unit 1F7 Business Center 3, Philexcel M.A. Roxas Highway, Clark Freeport Zone, Pampanga, represented herein by its Authorized Representative, BENITO T. SANTIAGO, JR., hereinafter called "the Supplier" of the other part.

WHEREAS, the Entity invited Bids for certain goods and ancillary services particularly for the Operations and Maintenance of New Clark City (NCC) Access Roads (Estate Management) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of PESOS: Twenty-Four Million Nine Hundred Forty-Four Thousand Three Hundred Eighty-Seven and 96/100 (PhP 24,944,387.96) (hereinafter called "the Contract Price")

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
 - i. Philippine Bidding Documents (PBDs);
 - Schedule of Requirements:
 - Technical Specifications;
 - General and Special Conditions of Contract;
 - Supplemental or Bid Bulletins, if any;
 - Winning bidder's bid, including the Eligibility requirements, Technical and ii. Financial Proposals, and all other documents or statements submitted;
 - Bid form including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the BCDA's bid evaluation;
 - Performance Security: iii.
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that





additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of Twenty-Four Million Nine Hundred Forty-Four Thousand Three Hundred Eighty-Seven and 96/100 (PhP 24,944,387.96) or such other sums as may be ascertained, the Contractor agrees to execute the Operations and Maintenance of NCC Access Roads (Estate Management) in accordance with his/her/its Bid.
- 4. The BCDA agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
