RESOLUTION NO. 2024-005 (Declaration of Shortlisted Consultants)

WHEREAS, the Bases Conversion and Development Authority (BCDA) is mandated under Republic Act No. 7227, as amended by Republic Act No. 7917, to accelerate the sound and balanced conversion into alternative productive uses of the Clark and Subic military reservations and their extensions, to raise funds by the sale of portions of Metro Manila Military Camps and to apply said funds for the development and conversion into alternative productive uses of these properties;

WHEREAS, on 30 April 2024, the BCDA, through its Bids and Awards Committee for Consulting Services (BAC-C), posted a Request for Expression of Interest (REI) including the bidding documents in PhilGEPS, the BCDA Website, and in a conspicuous place within the premises of BCDA for the Procurement of Consulting Services for the Construction Management and Supervision (CMS) for the Construction of Married Enlisted Personnel Quarters (MEPQ) at NSPL Cavite under Section 10 - Competitive Bidding of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184, with an Approved Budget for the Contract (ABC) in the amount of Pesos: Nine Million Seven Hundred Twenty Thousand Four Hundred Eighty and 00/100 (PhP9,720,480.00), inclusive of all applicable taxes and fees:

WHEREAS, in response to the said advertisement of the REI and bidding documents, one (1) prospective bidder submitted their Eligibility Documents for the Procurement of Consulting Services for the Construction Management and Supervision (CMS) for the Construction of Married Enlisted Personnel Quarters (MEPQ) at NSPL Cavite prior to the set deadline for submission on 21 May 2024 at 9:00 a.m., to wit:

1) ArkiNovus Asia Corp and Meinhardt Philippines, Inc. (Joint Venture)

WHEREAS, Section 30.1 of the 2016 Revised IRR of R.A. No. 9184 provides:

"xxx... the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a

non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed." xxx"

WHEREAS, on 21 May 2024, the Eligibility Documents of the sole prospective bidder were opened and subjected to a preliminary evaluation by determining the presence or absence of the required documents using the non-discretionary "pass/fail" criterion;

WHEREAS, the submitted Eligibility Documents of the said prospective bidder were subjected to detailed evaluation and shortlisting on 22 May 2024 to 29 May 2024 in accordance with Section 24 of the 2016 RIRR of R.A. No. 9184, and using the criteria and rating system for shortlisting as provided under Clause 9.2 of Eligibility Data Sheet (EDS) for the consulting services;

WHEREAS, the Technical Working Group (TWG) presented the results of the evaluation of the Eligibility Documents and shortlisting, and the BAC-C deliberated on the results on 30 May 2024;

WHEREAS, the results of the Evaluation/Eligibility Check and Shortlisting likewise show that ArkiNovus Asia Corp and Meinhardt Philippines, Inc. (Joint Venture) was rated "PASSED" and garnered a total score above the required minimum score of 70%, to wit:

- 2) Issue a Notice of Eligibility and Shortlisting to the aforementioned Eligible and Shortlisted prospective bidder to attend the Pre-bid Conference for the Procurement of Consulting Services for the Construction Management and Supervision (CMS) for the Construction of Married Enlisted Personnel Quarters (MEPQ) at NSPL Cavite; and
- Approval by the Office of President and Chief Executive Officer of the foregoing findings.
