WHEREAS, on 24 June 2024 (Monday) at 10:00 A.M., during the Opening of Bids, the BAC-G, opened the first envelopes of the aforementioned bidders containing the eligibility and technical requirements of the bidders, and subjected to a preliminary examination by determining the presence or absence of the required documents, using a non-discretionary “pass/fail” criterion.
