PROCUREMENT OF HUMAN RESOURCE INFORMATION SYSTEM (HRIS) RESOLUTION No. BG-2024-033

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through its 2024 Corporate Operating Budget (COB), applied the sum of **Seven Million Six Hundred Thousand Pesos and 00/100 Only (Php7,600,000.00), inclusive of VAT and all other applicable government taxes, fees, and charges**, as the Approved Budget for the Contract (ABC) for the **Procurement of Human Resource Information System (HRIS)**.

A copy of the approved Bids and Awards Committee for Goods (BAC-G) Annual Procurement Plan for CY 2024 is hereto attached as "Annex A."

WHEREAS, BAC-G, through its Secretariat, advertised the Invitation to Bid (ITB), including the bidding documents, on 30 May 2024 on the following platforms:

1. DBM - Philippine Government Electronic Procurement System (PhilGEPS);
2. BCDA Website; and
3. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to the advertisement, BAC-G conducted the Pre-bid Conference on 11 June 2024 at 10:00 A.M. (Tuesday) at the BCDA Corporate Center, Bonifacio Global City, Taguig City, which was attended by the following seven (7) prospective bidders, as follows:

1. Asiagate Networks, Inc.
2. Doña Alejandra Inc. (Doña)
3. Macrologic Diversified Technologies, Inc.
4. Mara Linux and Business Solutions Inc.
5. My Creative Panda Inc.
6. Time Free Solutions
7. Wizzard Technologies, Inc.

WHEREAS, two (2) bidders submitted their bids before the deadline of submission and receipt of bids on 28 June 2024 (Friday) at 1:00 P.M., to wit:

1. Doña Alejandra Inc.
2. Asiagate Networks, Inc.

WHEREAS, on 28 June 2024 (Friday) at 1:00 P.M., during the 'Opening of Bids', BAC-G, through the Technical Working Group (TWG), opened the first envelope of the bidders named above, subject to a preliminary examination by determining the presence or absence of the required documents, using a non-discretionary "pass/fail" criterion and noted the following:

WHEREAS, the financial envelope submitted by "Doña" was opened and subjected to a preliminary evaluation by determining the presence or absence of the required financial documents using a "pass/fail" criterion.

WHEREAS, BAC-G, through the Technical Working Group (TWG), proceeded with the detailed evaluation of the submitted Financial Proposal of the eligible bidder, to wit:

WHEREAS, in view of the results of the detailed evaluation and consistent with Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184, "Doña", as the bidder with the **Single Calculated Bid (SCB)**, was subjected to Post-Qualification to determine if it is legally, technically, and financially capable to undertake this procurement and responsive to all bidding requirements, including the specifications/terms of reference as stated in the bidding documents;

WHEREAS, on 06 August 2024 (Tuesday), during the deliberation of post-qualification, BAC-G concurred with the findings of the TWG that "Doña" is eligible, technically, legally and financially capable to undertake the project and its recommendation to declare **Doña Alejandra Inc.**, as the bidder with Single Calculated and Responsive Bid (SCRB) for this Project, in the amount of **Five Million Three Hundred Twenty Thousand Pesos and 68/100 Only (Php5,320,000.68)**, inclusive of VAT and other applicable taxes and fees.

The Post-Qualification Report is hereto attached as Annex "E";

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby RESOLVE, as it is hereby RESOLVED:

1. To declare **Doña Alejandra Inc.**, as the Single Calculated and Responsive Bidder (SCRB) for the **Procurement of Human Resource Information System (HRIS)**;
2. To award the contract to **Doña Alejandra Inc.** as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of Human Resource Information System (HRIS), in the total amount of **Five Million Three Hundred Twenty Thousand Pesos and 68/100 Only (Php5,320,000.68)**, inclusive of VAT and other applicable taxes and fees; and,
3. To direct the **Information and Communications Technology Department (ICTD)**, being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award (NOA), duly executed agreement/contract, and Notice To Proceed (NTP).
