PROCUREMENT OF GLOBAL NAVIGATION SATELLITE SYSTEM (GNSS) BASE/ROVER PACKAGE WITH COMPLETE GNSS TERRESTRIAL BUNDLE SOFTWARE

RESOLUTION NO. BG-2024-038

WHEREAS, the **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through its 2024 Corporate Operating Budget (COB), has bid out the Procurement of BCDA Global Navigation Satellite System (GNSS) Base/Rover Package with Complete GNSS Terrestrial Bundle Software with an Approved Budget for the Contract (ABC) of **FIVE MILLION NINE HUNDRED THOUSAND PESOS and 00/100 (Php5,900,000.00)**, inclusive of VAT and all other applicable government taxes, fees, and charges;

WHEREAS, on 10 September 2024, BAC-G, through its Secretariat, advertised/posted the Invitation to Bid, including the bidding documents, on the following platforms:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose within the premises of BCDA.

WHEREAS, BAC-G conducted a Pre-bid Conference on 17 September 2024 at 10:00 AM, which was attended by the following prospective bidders:

- a. Charles Cunanan Builders
- b. RASA Surveying
- c. NR Eustaquio Enterprises Inc.
- d. Argotek Inc.; and
- e. SITECH PHL Inc.

WHEREAS, BAC-G issued Bid Bulletin No. 01 dated 24 September 2024, to clarify the concerns raised by the prospective bidders during the Pre-bid Conference, which was also sent to the prospective bidders via email;

WHEREAS, in response to the advertisement, three (3) bidders submitted their bids before the deadline of submission on 01 October 2024 (Tuesday) at 9:00 AM at the BCDA Corporate Center, Bonifacio Global City, Taguig City. The three (3) bidders are as follows:

- a. ARGOTEK Inc.
- b. NR Eustaquio Enterprises Inc.
- c. SITECH PHL Inc.

WHEREAS, during the Opening of Bids on 01 October 2024 at 10:00 AM, BAC-G opened the eligibility and technical proposals of the three (3) bidders and were noted “passed”;

WHEREAS, BAC-G, through its Technical Working Group (TWG), proceeded with the detailed evaluation of the Financial Proposals submitted by the three (3) bidders and noted the following:

WHEREAS, in view of the results of the detailed bid evaluation and consistent with Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184, **SITECH PHL INC.**, as the Lowest Calculated Bidder (LCB), was subject to Post-Qualification to determine if it is legally, technically, and financially capable to undertake the procurement and if its submissions are responsive to all the bidding requirements, including the specifications/terms of reference as stated in the bidding documents;

The Detailed Bid Evaluation Report and the Abstract as Calculated is hereto attached as Annex B;

WHEREAS, on 18 October 2024, during the Deliberation of the Results of Post-Qualification, BAC-G declared that **SITECH PHL INC.** as eligible, technically, legally, and financially capable of undertaking the project and recommended to declare **SITECH PHL INC.** as the bidder with Lowest Calculated and Responsive Bid (LCRB) for the Project;

The Post-Qualification Report is hereto attached as Annex C;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

1. To declare **SITECH PHL INC.** as the Lowest Calculated and Responsive Bidder (LCRB) for the **Procurement of Global Navigation Satellite System (GNSS) Base/Rover Package With Complete GNSS Terrestrial Bundle Software;**


2. To award the contract to **SITECH PHL INC.**, being the LCRB for the Project, in the amount of **Five Million Two Hundred Thirty Thousand Pesos (Php5,230,000.00)**, inclusive of VAT and all other applicable government taxes, fees, and other charges.
3. To direct the **Land and Assets Development Department (LADD)**, being the end-user unit, to submit to BAC-G the duly conformed Notice of Award (NOA), duly executed agreement/contract, and Notice To Proceed (NTP).
