1. Instructions to Bidders (ITB) Clause 21.2

The bidder must have completed, within the period specified in the Invitation to Bid, a Single Contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC adjusted to current prices using the PSA's CPI; or at least two (2) similar completed contracts with the aggregate amount equivalent to at least fifty percent (50%) of the ABC adjusted to current prices using the PSA's CPI, and the largest of these similar contracts must be equivalent to at least half of the percentage (25%) of the ABC.

For this purpose "similar contracts' shall refer to contracts involving the supply and delivery of Internet of Things (IoT) Devices with Web Platforms.


