Declaration of Highest Financial Bid

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the Disposal and Appraisal Committee (DAC), has put on bid the **Disposal through Sale of One (1) Lot Used Vehicle Spare Parts and Assorted Scrap Materials** with a floor price value of **Nine Thousand Five Hundred Two & 50/100 (Php 9,502.50)**, inclusive of all applicable taxes and fees;

WHEREAS, on 20 September 2024, the DAC Technical Working Group (TWG) reported the inventory and appraisal of various vehicle spare parts and scrap/junk properties intended for disposal as listed under the attached Waste Material Report (WMR);

WHEREAS, on 20 September 2024, the DAC held a Pre-Auction Conference regarding the Disposal through Sale of One (1) Lot Used Vehicle Spare Parts and Assorted Scrap Materials with an estimated value of Nine Thousand Five Hundred Two and 50/100 (Php9,502.50), inclusive of VAT and all applicable fees;

WHEREAS, in DAC's memo dated 11 October 2024, the Executive Vice President, Gisela Z. Kalalo approved the recommended appraised value and the immediate disposal of the aforementioned items through sale as one (1) lot;

WHEREAS, on 15 October 2024, the DAC through its Secretariat, advertised the Invitation to Bid in the following platforms:

- a. BCDA Website;
- b. In conspicuous place reserved for the purpose in the premises of BCDA; and
- c. In conspicuous places in the locality where the properties may be sold.

WHEREAS, on 22 October 2024, the DAC-TWG along with a representative from the Commission on Audit (COA) and prospective bidders, carried out an on site inspection of the items for disposal. During the aforementioned inspection, five (5) prospective bidders participated;

WHEREAS, in response to the advertisement and inspection, twenty one (21) prospective bidders bought the bid documents, namely:

WHEREAS, out of the aforementioned interested bidders, eight (8) submitted their bids prior to the set deadline of submission of bids for the project on 28 October 2024 at 1:30PM, namely:

WHEREAS, none of the members of the BCDA Disposal and Appraisal Committee (DAC) are in any way related to any of the participating bidders up to fourth civil degree of consanguinity or affinity;

WHEREAS, on 28 October 2024, the envelope containing the technical and financial bids of the eight (8) proponents were opened and subjected to preliminary evaluation by determining the absence or presence of the required documents;

WHEREAS, after checking the required documents all eight (8) bidders, were declared by the DAC as "Passed";

WHEREAS, after opening financial proposals of the eight (8) proponents, the result of the bidder's bid are as follows:

- To recommend to the BCDA Senior Vice President for Corporate Services Group the award of the disposal through sale to **LUCKY SUN ENTERPRISES**, with a highest bid price in the amount of **Pesos: Thirteen Thousand Six Hundred Ninety Nine & 99/100 the (Php13,699.99)**, inclusive of VAT and all applicable taxes and fees.
