## RESOLUTION NO. 2024-023 DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BID (LCRB)

The BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the General Appropriations Act (GAA), has put on a bid the CONSTRUCTION OF BANGKO SENTRAL NG PILIPINAS (BSP) ACCESS ROAD IN NEW CLARK CITY (NCC) with an Approved Budget for the Contract (ABC) in the sum of Pesos: Three Hundred Twenty-One Million Two Hundred Twenty-Seven Thousand Two Hundred Two and 75/100 Centavos (Php 321,227,202.75), inclusive of all applicable taxes and fees.

**WHEREAS**, the BAC-I, through its Secretariat, advertised the Invitation to Bid on 27 September 2024 on the following platforms:

WHEREAS, during the said preliminary evaluation and after checking the sufficiency of the required documents as regards their presence or absence, the BAC-I declared that the bids of the following eleven (11) bidders as "passed" after satisfying the Eligibility Requirement, to wit:

WHEREAS, the second envelopes, which contained the financial proposals of the eleven (11) proponents who "passed" the preliminary examination of the eligibility/technical requirements, were opened and were likewise subjected to a preliminary evaluation of the financial proposals. After checking the sufficiency of the required documents as regards its presence or absence, the BAC declared the bids of the ten (10) proponents "passed" and were considered for the detailed evaluation and comparison of financial bids. WHEREAS, the bid of LSD CONSTRUCTION & SUPPLIES was declared by the BAC-I as "failed" due to its failure to indicate the word "none" in its Financial Bid if there is no discount being offered, which is a requirement under the Instruction to Bidders (ITB) Clause 11 (Note 3) of the Bid Data Sheet (BDS) of the Bidding Documents.

WHEREAS, Section 32.2 of the RIRR of R.A. 9184 states, "For the procurement of Goods and Infrastructure Projects, the BAC shall evaluate the financial component of the bids to determine the Lowest Calculated Bid. xxx."

WHEREAS, on 12 to 18 November 2024, in accordance with Section 32.2 of the RIRR of R.A. 9184 mentioned above, the BAC Technical Working Group (TWG) conducted the detailed evaluation of the Financial Component of the bids of the aforementioned ten (10) proponents.

WHEREAS, ZUIWIN ENTERPRISES AND CONTRACTOR failed to provide in its Detailed Cost Estimates (DCE) items required under Part A (Facilities for the Engineer), Part B (Other Requirements), Part C (Earthworks), Part D (Subbase and Base Course), Part E (Surface Course) and Part G (Drainage and Slope Protection Structures) and was thereby declared by the BAC-I as disqualified pursuant to Section 32.2.1 (a) of the RIRR of R.A. 9184, which provides that:

"The BAC shall immediately conduct a detailed evaluation of all bids using non-discretionary criteria in considering the following:

a. <u>Completeness of the bid</u>. Unless the Instruction to Bidders specifically allow partial bids, bids not addressing or providing all of the required item in the Bidding Documents including, where applicable, bill of quantities, shall be considered non-responsive and, thus, automatically disqualified. xxx"

WHEREAS, after the said detailed evaluation of the Financial Component, the nine (9) proponents were ranked in ascending order based on their financial bids or total bid price as calculated, evaluated, and/or corrected for computational errors to identify the bidder with the Lowest Calculated Bid (LCB) who shall undergo the post-qualification. The table below shows the bid amount of the nine (9) proponents (as calculated):

WHEREAS, from 19 November 2024 to 02 December 2024, the BAC-I TWG conducted the Post-Qualification on the Eddmari Construction and Trading, pursuant to Section 34 of the RIRR of R.A. 9184;

WHEREAS, on 09 December 2024, the BAC-I deliberated the following results of post-qualification and found the bid of EDDMARI CONSTRUCTION AND TRADING to be responsive and compliant with the requirements:
