RESOLUTION NO. BG-2024-043

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through its 2024 Corporate Operating Budget (COB), intends to procure the services of **two (2)** Appraisal Companies for the Valuation of Various BCDA Properties ("The Project"), with Invitation to Bid No. (reference no.)/Project ID No. of BG2024-172;

WHEREAS, BCDA intends to apply the amount of **ONE MILLION EIGHT HUNDRED SIXTY-TWO THOUSAND FIVE HUNDRED SIXTY PESOS (Php1,862,560.00)**, inclusive of Value Added Tax (VAT) and all other applicable government taxes, charges, and fees, corresponding to the Approved Budget for the Contract (ABC) **per Appraiser**;

WHEREAS, the total ABC of THREE MILLION SEVEN HUNDRED TWENTY-FIVE THOUSAND ONE HUNDRED TWENTY PESOS (Php3,725,120.00), inclusive of VAT and all other applicable government taxes, charges, and fees, shall correspond to the procurement of appraisal services of two (2) Appraisal Companies;

Bids and Awards Committee for Goods (BAC-G) CY 2024 Annual Procurement Plan attached as "Annex A".

WHEREAS, on 05 October 2024, BAC-G, through its Secretariat, advertised/posted the Invitation to Bid, including the bidding documents on the following platforms:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted a Pre-bid Conference on 14 October 2024 at 10:00 AM, which was attended by the following prospective bidders:

- a. Cal-Fil Appraisal and Management, Inc.;
- b. Vitale Valuation Services, Inc.; and
- Cesson Appraisal Corp.

WHEREAS, BAC-G issued Bid Bulletin No. 01 dated 14 October 2024, providing the presentations discussed during the Pre-Bid Conference.

WHEREAS, BAC-G issued Bid Bulletin No. 02 dated 21 October 2024 clarifying queries raised by the prospective bidders during the Pre-bid Conference, which was also sent to the prospective bidders via email;

WHEREAS, in response to said advertisement, two bidders, CAL-FIL APPRAISAL AND MANAGEMENT, INC. and VITALE VALUATION SERVICES, INC., submitted their bids for the procurement of the services of Appraiser 1 before the deadline of submission of bids at 9:00 AM on 28 October 2024 (Monday) at the BCDA Corporate Center, Bonifacio Global City, Taguig City;

WHEREAS, during the Opening of Bids on 28 October (Monday) at 10:00 AM at BCDA Corporate Center, Bonifacio Global City, Taguig City, BAC-G opened the eligibility and technical documents of the two bidders to determine their compliance with the requirements of the project;

WHEREAS, after confirming that it met the eligibility and technical criteria, the financial envelope submitted by CAL-FIL APPRAISAL AND MANAGEMENT, INC. was opened and underwent a preliminary evaluation to determine the presence or absence of the required financial documents using a "pass/fail" criterion;

WHEREAS, the submission of the VITALE VALUATION SERVICES, INC. was declared FAILED due to non-compliance on the Technical Compliance Form, thus its financial bid envelope remains sealed and unopened;

WHEREAS, BAC-G, through the Technical Working Group (TWG), proceeded with the detailed evaluation of the submitted Financial Proposal of CAL-FIL APPRAISAL AND MANAGEMENT, INC. and noted the following:

WHEREAS, in view of the results of the detailed bid evaluation and consistent with Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184, CAL-FIL APPRAISAL AND MANAGEMENT, INC. as the Single Calculated Bidder (SCB), was subjected to Post-Qualification to determine if it is legally, technically, and financially capable to undertake this procurement and responsive to all bidding requirements, including the specifications/terms of reference as stated in the bidding documents;

WHEREAS, pursuant to Section 34.4 of the 2016 RIRR of R.A. No. 9184, which states that,

"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower".

WHEREAS, on 18 November 2024, during the Deliberation of the Results of Post-Qualification, BAC-G declared that CAL-FIL APPRAISAL AND MANAGEMENT, INC., is eligible, technically, legally, and financially capable to undertake the project and recommended declaring CAL-FIL APPRAISAL AND MANAGEMENT, INC. as the bidder with Single Calculated and Responsive Bid (SCRB) for this Project;
