

CONTRACT AGREEMENT

**FOR THE PROCUREMENT OF BCDA IT EQUIPMENT FOR
2025**

This AGREEMENT made and entered into this 21 MAY 2025 between the:

BASES CONVERSION AND DEVELOPMENT AUTHORITY ("BCDA"), a government instrumentality vested with corporate powers under Republic Act (RA) 7227 (Bases Conversion and Development Act of 1992), with offices at BCDA Corporate Center, 2nd Floor, Bonifacio Technology Center, 31st St., corner 2nd Avenue, Bonifacio Global City, Taguig, Metro Manila 1634, represented by its Executive Vice President, **ATTY. GISELA Z. KALALO**, duly authorized for this purpose provided in Section V. 178, Page 27 of the BCDA's Revised Manual of Approval dated 22 November 2017, a copy of which is hereto attached as Annex "A" and made an integral part hereof and hereinafter referred to as "**BCDA**";

The **COLUMBIA TECHNOLOGIES, INC.**, with registered office at 1136-1146 J. Nakpil St. Malate Manila, Philippines, represented herein by its Authorized Representative/ Account Manager, **HELEN GRACE L. PASAG**, who is duly authorized for this purpose evidenced by its Secretary Certificate dated 15 May 2025, a copy of which is hereto attached as Annex "B" and made an integral part hereof, hereinafter referred to as "**SUPPLIER**".

WHEREAS, the BCDA invited Bids for certain goods and ancillary services, particularly **Procurement of BCDA IT Equipment for 2025**, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Million Eight Hundred Thirty Thousand Four Hundred Pesos and 00/100 (Php 4,830,400.00)** inclusive of VAT and all applicable taxes and fees (hereinafter called "the Contract Price").

ACCORDINGLY, the Parties agree as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as an integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

- 3. In consideration for the sum of Four Million Eight Hundred Thirty Thousand Four Hundred Pesos and 00/100 (Php 4,830,400.00) inclusive of VAT and all applicable taxes and fees or such other sums as may be ascertained, Columbia Technologies, Inc., agrees to **supply the IT Equipment** in accordance with his/her/its Bid.
- 4. BCDA agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. Anti-Bribery. The **SUPPLIER** has not made and will not make any offer, promise to pay, or authorization of the payment of any money, gift, or any other inducement to any official, political party, employee of Government, or any other person, in contravention with applicable laws in connection with the execution of this Contract and performance of its obligations thereunder. Violation of this provision shall be a ground for immediate termination of this Contract.
- 6. Assignment. **SUPPLIER** shall not assign this Contract or subcontract any portion of it, without BCDA's prior written consent, subject to applicable rules and regulations on subcontracting. Prior to the assignment or subcontracting and the approval by BCDA thereof, **SUPPLIER** must disclose to BCDA the name of its assignee/s or subcontractor who/which should have a written agreement/s with **SUPPLIER** indicating: (i) that the assignee/s or subcontractor/s are aware and shall abide with all the terms and conditions of this Contract, as may be applicable, (ii) that the terms of the assignment/subcontract shall not exceed the term of this Contract, and (iii) the detailed terms of the assignment/subcontract.

7. To ensure continuing compliance with tax laws pursuant to Executive Order No.398:
- a. **SUPPLIER** shall pay taxes in full and on time.
 - b. **SUPPLIER** is likewise required to regularly present, within the duration of the Contract, a tax clearance from the Bureau of Internal Revenue (BIR) as well as a copy of its income and business tax returns duly stamped and received by the BIR and duly validated with the tax payments made therein.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on 21 May 2025 in Taguig City, Philippines.
