

TERMS OF REFERENCE

LEASE OF VENUE FOR THE BCDA CORPORATE TEAM BUILDING ACTIVITY 2025 *(including use of the venue, accommodations, and meals)*

I. SCOPE OF SERVICE

The service provider should be able to provide the venue, facilities, accommodations, and meals with the following specifications:

4. Menu for the entire function shall be submitted for review by the BCDA committee.

3. Bed accommodations for sharing rooms- No floor mattresses.	
4. Rooms with clean bathrooms, free-flowing tap water, toiletries and linens

II. MODE OF PROCUREMENT

The procurement through the Lease of Venue shall be undertaken in accordance with Section V (D) (9) of Annex "H" (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184.

III. EVALUATION AND SELECTION CRITERIA

BID proposals shall be evaluated in accordance with the Table of Rating Factors for Lease of Venue of the 2016 Revised IRR RA 9184. The 2025 Team Building and Anniversary shall conduct an ocular inspection. The passing rate should be at least 80% or higher.

IV. APPROVED BUDGET FOR THE CONTRACT

The service provider shall bid for all items stated in the Terms of reference and shall not exceed the Approved Budget for the Contract in the amount of **FOUR MILLION PESOS (PHP 4,000,000.00) inclusive of all government taxes and fees.**

V. PAYMENT SCHEME

The mode of payment to the winning bidder shall be as follows:

1. Full payment shall be settled on the day of the event
2. Check payment shall be made to the account of the hotel/venue
3. In excess of 500 pax, the same rate shall apply per head

VI. DOCUMENTARY REQUIREMENT

1. Valid and current Mayor's Permit/Municipal License
2. Income/Business Tax Return
3. PhilGEPS registration No.

VII. COMPLIANCE WITH LAWS, RULES AND REGULATIONS GOVERNING PROCUREMENT

BCDA reserves the right to accept or reject any or all proposals, to waive any defect or informality thereon or minor deviations which do not affect the substance and validity of any or all of the proposals, or to annul the selection process and reject all at any time prior to award, without thereby incurring any liability to the affected proponents.

BCDA reserves the right to reject the proposal of any proponent who:

- a. does not offer the required services as provided for in this Terms of Reference;
- b. is discovered to have suppressed, disclosed, or falsified information; or
- c. failed to satisfactorily perform/complete any contract previously taken.

BCDA reserves the right to rescind the contract, without prejudice to other courses of action and remedies open to it.
