Clarification under Technical Specification 5.6 - SolarWinds Network Performance Monitor SLX (unlimited elements- Standard Polling Throughput) – License with 1st-year Maintenance Does this item don't have a separate Annex?	None. The SolarWinds Network Performance Monitor SLX (unlimited elements- Standard Polling Throughput) is the full description of the license needed.
2. Clarification under Technical Specification 6.6 - Contact service in receive calls /emails from Onsite Engineers or BCDA Is the contact Service refers to a Helpdesk System which has a ticketing system which will be assigned to the appropriate IT personnel based on the issue's type and priority?	Yes.
3. Clarification under Technical Specification 7.0 - On Site Engineers - 3 pax Are the On-Site Engineers should be a regular employee of the Bidder?	No. The On-Site Engineers do not need to be regular employees of the Bidder. The bidder should attach the Curriculum Vitae and Certificate of Employment of their nominated On-site Engineers during Bid submission.
4. Clarification under Technical Specification 7.2 - Each engineer must have at least 2 years of experience as network technical support. Are the On-Site Engineers should be a regular employee of the Bidder?	No. The On-Site Engineers do not need to be regular employees of the Bidder. The bidder should attach the Curriculum Vitae Certificate of Employment of their nominated On-site Engineers during Bid submission.

Clarification under Technical Specification Other Requirement no, 5. - Bidder must have locally-based Cisco-Certified personnel possessing any of the following valid certification combinations:</p> <ul style="list-style-type: none"> • Cisco Certified Internetwork Expert (CCIE) and Cisco Certified Network Associate (CCNA); or • Cisco Certified Network Professional (CCNP) and Cisco Certified Network Associate (CCNA); or • Cisco Certified Internetwork Expert (CCIE), Cisco Certified Network Professional (CCNP), AND Cisco Certified Network Associate (CCNA). <p>Should the Cisco Certified Personnel be a regular employee of the Bidder?</p>	<p>Yes. The locally-based Cisco-Certified personnel needs to be a regular employee of the Bidder.</p> <p>The bidder should attach the Curriculum Vitae and Certificate of Employment for each of their locally-based Cisco-Certified personnel during its Bid submission.</p>
