DECLARATION OF FAILED BIDDING

**CONSULTING SERVICES FOR THE FOURTH PHASE OF THE
BCDA TRANSFORMATION AND CORE VALUES PROGRAM**

WHEREAS, The BCDA President and CEO approved the procurement of the above consulting service with an Approved Budget for the Contract (ABC) as follows inclusive of all applicable government taxes, fees and other charges, to commence upon receipt of the Notice to Proceed (NTP):

WHEREAS, On 6 November 2020, the Bids and Award Committee for Consulting Services (BAC-C) advertised the Request for Expression of Interest for the CONSULTING SERVICES FOR THE FOURTH PHASE OF THE BCDA TRANSFORMATION AND CORE VALUES PROGRAM in the BCDA Website, PhilGEPS and in a conspicuous place in the premises of BCDA;

WHEREAS, The procurement of the said services shall be undertaken through competitive bidding using Quality Cost-Based Evaluation (QCBE) procedure with 70% minimum score to be shortlisted.

WHEREAS, In response to the said advertisement, the following firms responded and secured the Eligibility Documents:

- a. NxtLevel Experience Training and Consultancy, Inc.; and
- b. Career Clinic and Enterprise Solutions, Inc.

WHEREAS, The above proponents submitted their accomplished eligibility documents before the deadline of submission on 17 November 2020 (Tue), 12:00 NN.

WHEREAS, On the same day, at 1:00 PM, the accomplished eligibility documents of the two (2) proponents were opened and checked based on the non-discretionary “pass/fail” criterion.

WHEREAS, During the Opening of the Eligibility Documents, NxtLevel Experience Training and Consultancy Inc. failed to submit the following required documents:

- a. Valid PhilGEPS Certificate of Registration under Platinum Membership;
- b. Business Permit;
- c. Audited Financial Statement; and
- d. Tax Clearance

WHEREAS, based on the foregoing, NxtLevel Experience Training and Consultancy was evaluated to be ineligible.

WHEREAS, the results of evaluation based on the submitted Eligibility Proposals of the other proponent are as follows:

WHEREAS, based on the qualifications required under the Terms of Reference and detailed evaluation criteria for shortlisting, the lone proponent garnered a total score below the required minimum score of 70%.

NOW, THEREFORE, we, the members of the Bids and Awards Committee for Consulting Services, hereby RESOLVE, as it is hereby RESOLVED to:

1. DECLARE as ineligible NxtLevel Experience Training and Consultancy, Inc for failure to submit the required eligibility documents and Career Clinic and Enterprise Solutions, Inc. for not meeting the required minimum score to pass the eligibility stage;
2. DECLARE a **FAILURE OF BIDDING** for the Procurement of CONSULTING SERVICES FOR THE FOURTH PHASE OF THE BCDA TRANSFORMATION AND CORE VALUES PROGRAM;
3. ENDORSE the documents to the Corporate Planning Department (CPD) for the conduct of a mandatory review of the terms, conditions, specifications and cost estimates pursuant to Section 35 of the Revised IRR of RA 9184;
4. PROCEED with the re-bidding for the Procurement of CONSULTING SERVICES FOR THE FOURTH PHASE OF THE BCDA TRANSFORMATION AND CORE VALUES PROGRAM upon endorsement by the end-user to the BAC-C for re-bidding, and completion of the aforementioned mandatory review; and
5. DIRECT the BAC-C Secretariat to notify NxtLevel Experience Training and Consultancy, Inc and Career Clinic and Enterprise Solutions, Inc. on the results of the Eligibility Check and Shortlisting and Failure of Bidding.


