RESOLUTION NO. BG2020 - 018

PROCUREMENT OF GROCERIES FOR THE 2020 BCDA CHRISTMAS GIFT BASKET

WHEREAS, the Bases Conversion and Development Authority (BCDA), intends to procure groceries for the 2020 BCDA Gift Baskets as part of its Yuletide Celebration for the year 2020;

WHEREAS, in a memo (*Annex A*) dated 23 November 2020, President and CEO Vivencio B. Dizon approved the following:

1. Budget of Php4,024,000.00 for the 2020 Yuletide Celebration of BCDA chargeable to the 2020 Budget for Christmas Activities; and
2. Commencement of the procurement process with respect to the activities related to the Yuletide Celebration including the procurement of the Christmas Gift Baskets;

WHEREAS, in its memo to the Bids and Awards Committee for Goods (BAC-G) dated 01 December 2020 (*Annex B*), the BCDA Yuletide Committee requested the procurement of groceries for the 2020 BCDA Gift Baskets through Negotiated Procurement of "Agency-to-Agency", pursuant to Section 53.5 of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184;

WHEREAS, based on the representation of the BCDA Yuletide Committee to the BAC-G, the following applicable conditions for Agency-to-Agency arrangement are satisfied:

1. Based on the initial canvass, the prices of items offered by the Armed Forces of the Philippines Commissary and Exchange Services (AFPCES) are lower than the prices offered by other grocery stores, hence AFPCES has the lowest calculated bid (please see attached Abstract of Quotations as *Annex C*). Hence, it is more advantageous and economical for the government to enter into an Agency-to-Agency Agreement with AFPCES.
2. The AFPCES is one the Armed Forces of the Philippines' Wide Support Units tasked to provide support to the military and civilian personnel by means of retail merchandising and offering goods at the lowest price and free of tax (*Annex D*).
3. The AFPCES has a capacity to deliver the groceries based on the accomplished Request for Quotation submitted by AFPCES.

NOW, THEREFORE, foregoing premises considered, we, the Members of the BAC for Goods hereby **RESOLVE**, as it is hereby resolved, to recommend the following:

1. Procurement of groceries for the 2020 Christmas Baskets in connection with the BCDA Yuletide Celebration for the year 2020 through Negotiated Procurement of

“Agency-to-Agency”, pursuant to Section 53.5 of the RIRR of RA 9184 ; and

2. Award the contract to the AFPCES for the procurement of groceries for Six Hundred Twenty Three (623) Christmas Baskets in the total amount of **Three Million Ninety Seven Thousand Three Hundred Eighty Nine Pesos & 00/100 (Php3,097,389.00)**.
