I. CALL TO ORDER

II. BIDS AND AWARDS COMMITTEE FOR GOODS

Opening of Bids (Bidding of Fit-Out, Repair, Local Area Network, Supply and Delivery of IT Equipment and Software for the Subic-Clark Railway Project Management Office)

1. The Commission on Audit (COA) and IASO were invited to observe. Ms. Margie O. Padre, representative of IASO and Ms. Eunice Cabangon, representative of COA, attended the Opening of Bids.
2. The end-user, Subic-Clark Project Management Office, was represented by Ms. Leonor Rivera and Arch. Judene Lagoy.

III. HIGHLIGHTS OF THE MEETING

BAC-G Vice Chairperson Atty. San Pablo, welcomed the attendees to the Opening of Bids and acknowledged the presence of the bidders' representatives. She added that four bidders submitted bid proposals for the project.

Vice Chairperson San Pablo then instructed the Technical Working Group (TWG) to proceed with the opening of bids and requested a representative of each bidder to witness and acknowledge every document presented during the opening and presentation of documents.

TWG Head Ms. Almira Clarianes, assisted by Mr. Donald Tolentino, opened and read all eligibility and technical documents submitted by the four bidders.

During the opening of the eligibility documents, three (3) of the bidders was declared Eligible and one (1) bidder, namely Three in One Construction and Trading was declared ineligible for the following reasons:

1. Failure to submit supporting documents for the Single Largest Completed Contract;
2. Failure to submit the Technical Specifications Compliance Form (Section VII of the Bid Documents); and
3. Failure to submit the Schedule of Requirements duly signed in every page by the principal bidder or the bidder's authorized representative (Section VI of the Bid Documents).

BAC-G then proceeded with the opening of the financial proposals of the three (3) eligible bidders for Lots B, C and D.
