## **BAC-C Resolution Declaring Failed Bidding**

## CONSULTING SERVICES FOR THE CONSTRUCTION MANAGEMENT AND SUPERVISION (CMS) OF THE DESIGN AND BUILD PROJECT FOR THE NATIONAL ACADEMY OF SPORTS (NAS) PHASE 1 AT NEW CLARK CITY

WHEREAS, The BCDA Board approved the procurement of the above consulting service with an Approved Budget for the Contract (ABC) in the amount of Pesos: Seventeen Million Fifty Two Thousand and 00/100 Pesos (PhP 17,052,000.00), inclusive of all applicable taxes and fees, to commence upon receipt of the Notice to Proceed (NTP);

WHEREAS, On 05 February 2021, the Bids and Awards Committee for Consulting Services (BAC-C) advertised the Request for Expression of Interest for the CONSULTING SERVICES FOR THE CONSTRUCTION MANAGEMENT AND SUPERVISION (CMS) OF THE DESIGN AND BUILD PROJECT FOR THE NATIONAL ACADEMY OF SPORTS (NAS) - PHASE 1 AT NEW CLARK CITY in the BCDA Website, PhilGEPS website, newspaper of national circulation and in a conspicuous place in the premises of BCDA continuously for seven (7) days;

**WHEREAS,** a Pre-Eligibility Conference was held on 09 February 2021 and that the following prospective bidders attended:

**WHEREAS,** no bid was received by the BCDA Central Receiving and Releasing Area (CRRA) by 12:00PM 16 February 2021, the deadline for the submission of the Eligibility Documents;

WHEREAS, pursuant to Section 35.1 of the Revised IRR of Republic Act No. 9184, to wit:

"The BAC shall declare the bidding a failure when:


(a) No bids are received;"
