Consultancy, Manpower, Training, and Assessment Center hereby commits to perform and deliver all of the obligations and undertakings, including the warranty provisions under the contract covering the procurement at hand. G.U.E.S.T. Consultancy, Manpower, Training, and Assessment Center further agrees and accepts that failure to perform or deliver any of such obligations and undertakings shall result in Blacklisting of G.U.E.S.T. Consultancy, Manpower, Training, and Assessment Center for two (2) years in all government procurement activities following the procedure under the

Moreover, in case advance payment was made or given, failure to perform or deliver any of said obligations and undertakings shall be sufficient grounds to constitute criminal liability for Swindling (Estafa) or the commission of fraud with unfaithfulness or abuse of confidence through misappropriating or converting any payment received by a person or entity under an obligation involving the duty to deliver certain goods or services, to the prejudice of the public and the government of the Philippines pursuant to Article 315 of Act No. 3815 s. 1930, as amended, or the Revised Penal Code;

Consultancy, Manpower, Training, and Assessment Center warrants for a period stipulated in the contract covering the procurement at hand that the Goods or Infrastructure projects to be delivered shall be free from defects and conform with quality standards and technical specifications of the said contract;


