5. Must bring their valid company ID during the said site inspection;
6. It is preferred that the interested bidders' representatives will bring copies or screenshots of their rapid or swab test results showing that they are negative of COVID-19;
7. Must wear face mask and face shield, and observe physical distancing throughout the site visit/inspection;
8. No cellphones, photographs or videos allowed inside the facilities.
