RESOLUTION NO. 14

(Declaration of Lowest Calculated and Responsive Bid)

The BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the 2021 General Appropriations Act (GAA), has put on bid the Contract for the Construction Of Various Structures And Facilities Within The 100-Hectare Area At Bataan Technology Park, Morong Bataan (Phase 1 Package 2), with an Approved Budget for the Contract (ABC) in the sum of Pesos: Three Billion Forty-Six Million Eight Hundred Sixty-Two Thousand Seven Hundred Eighty-Eight And 77/100 (Php3,046,862,788.77), inclusive of all applicable taxes and fees.

WHEREAS, the BAC-I, through its Secretariat, advertised the Invitation to Bid on 08 September 2021 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to the said advertisements, twenty (20) interested bidders purchased the bidding documents for the project and nineteen (19) submitted their bids on 20 October 2021, to wit:

WHEREAS, to determine the Lowest Calculated Bid (LCB), the BAC-I Technical Working Group (TWG) conducted the detailed evaluation of bids pursuant to Section 32.2 of the Revised IRR of RA 9184. The recommendations and results of the detailed evaluation of bids were presented by the TWG to the BAC-I for deliberation and approval;

WHEREAS, after the deliberation and approval of the BAC-I, the following ratings for the financial and technical proposals were determined:

WHEREAS, on 03 November 2021, the BAC-I posted in the BCDA website the BAC-I Resolution No. 10 declaring the Consortium of Rhodium 688 & Qingjian Group as the bidder with the Lowest Calculated Bid, followed by the Consortium of MSV Construction & Bina-Puri Holdings, and then by the Joint Venture of MAC Builders & CHEC Construction.









WHEREAS, of even date, the BAC-I through its Secretariat, issued Notices of Ineligibility to the following bidders:

- 1. JV of Monolith Construction and Stone of Hope Builders Development Corporation
- 2. Vista Green Builders, Inc.
- 3. Finmat International Resources, Inc.
- 4. Consortium of Viking Construction and Supplies and China Wuyi Co. Ltd
- 5. JV of Specified Contractors and Development Inc/ Horamabi Builders A-Win Enterprises
- 6. JV of Foundation Specialists, Inc. and Almeria International Construction Corporation
- 7. JV of Frontnine Konstruct and Wismon Construction and Development Corporation
- 8. JV of New San Jose Builders Inc. and Tryst Builders Enterprises
- 9. Phesco, Incorporated
- 10. Sta Clara International Corporation

WHEREAS, between 05 November 2021 and 09 November 2021, with the exception of Phesco, Inc., the BAC-I received requests for reconsideration from the above-mentioned bidders.

WHEREAS, the BAC-I deliberated the merits of each of the Requests/Motions for Reconsideration (MR) and decided on each of the MRs, as follows:

Decision: DENIED

In the detailed bid evaluation, the JV was declared ineligible on the following grounds:

- Non-indication of unit cost for Item 1100 (6)a of the Exterior Lighting System under Site Development in the Bill of Quantities (BOQ);
- 2. Non-submission of Certificate of Completion or Final Acceptance to support the SLCC.
- Insufficient experience of the nominated Structural Engineer for building projects. The Structural Engineer only has 20 months of experience for Building projects as against the required 3 years;
- 4. Insufficient experience of the nominated Geodetic Engineer (GE) for building projects. Based on the CV, the nominated GE has experience only on road projects but not on buildings.

In response to the MR, the BAC-I maintained that Item (a) is in violation of Section 32.2.1a of the Revised IRR of RA 9184 which states that "...where a required item is provided but no price is indicated, the same shall be considered as non-responsive...". For Item (b), the BAC-I is of the position that the submission of Certificate of Occupancy does not constitute compliance to the SLCC requirement. Nowhere in the Certificate of Occupancy does it certify that Monolith Construction and Development Corporation has completed the contract, nor does it say that the same has been accepted by the Project Owner.

Lastly, Clause 10.4 of the BDS specifically requires the Structural Engineer and Geodetic Engineer to have a minimum of 3 years of experience on building projects. Based on the submitted CV of the nominated Structural Engineer, the required experience on building projects cannot be determined since the vertical and horizontal components of the handled projects were not identified. In the case of the nominated GE, none of the projects listed in the CV pertain to building projects.

In view of the reasons above, the BAC-I resolved to deny the MR of the JV.

2. Vista Green Builders, Inc.

Decision: DENIED

In the detailed bid evaluation, Vista Green Builders, Inc. was declared ineligible due to non-indication of unit cost for Item 1100 (6)a of the Exterior Lighting System under Site Development in the BOQ, which, as the BAC-I stated in the notice, is in violation of Section 32.2.1.a of the Revised IRR of RA 9184.

The BAC-I reiterated the provisions of Section 32.2.1a of the Revised IRR of RA 9184, stating that "...where a required item is provided but no price is indicated, the same shall be considered as non-responsive...". It is with the same reason that the BAC-I resolved to deny the MR.

3. Finmat International Resources, Inc. (Finmat)

Decision: GRANTED

In the detailed bid evaluation, the pledged mobile crane was only 25 tons in capacity as determined from the Mobile Crane's model number indicated in the LTO OR/CR. The requirement is for a 50-ton mobile crane.

Finmat claimed that the LTO OR/CR was required in this bid only as a proof of ownership of the equipment and not as a proof of its capacity. Finmat further claimed that the pledged equipment has been upgraded to 50 tons capacity as shown in the submitted purchase order and photos. The BAC-I resolved to reconsider. Should Finmat be subsequently declared as the Lowest Calculated Bid (LCB) after resolving all the MRs, Finmat shall undergo the post-qualification activity where its pledged equipments' capacity can best be verified through actual tests and validated through additional documents to determine the bidder's compliance with the technical and legal requirements, including statutory laws, rules and regulations.

4. Viking Construction and Supplies and China Wuyi Co. Ltd (Consortium)

Decision: DENIED

In the detailed bid evaluation, the JV was declared ineligible on the following grounds:

- Nominated Project Manager did not meet the required 5 years of experience as Project Manager on building projects. The nominated Project Manager has only 3 years and 8 months experience as Project manager on Building Projects.
- 2. Nominated Site Engineer did not meet the required 2 years of experience as Site Engineer on building projects. The nominated Site Engineer has only 22 months experience as Site Engineer on Building Projects.

The JV attached additional documents on their MR to further support the CV of the nominated Project Manager and Site Engineer.

The BAC-I maintained their decision that the nominated Project Manager and Site Engineer failed to meet the required minimum number of years of experience. Section 55.1 of the Revised IRR of RA 9184 expressly prohibits bidders from submitting additional documents to correct any defect in the bid submitted. The additional documents submitted to support the CVs of the bidder's nominated key personnel are in the nature of a correction of its submitted bid which directly runs contrary to what the law specifically proscribed against.

5. Specified Contractors and Development Inc/ Horamabi Builders A-Win Enterprise and Solutions Inc (Joint Venture)

Decision: GRANTED

In the detailed bid evaluation, the LTO OR/CR of the pledged water truck showed a capacity of 6363 kg or equivalent to 6363 L, which did not meet the required equipment capacity of 16,000 L.

Based on the MR, the JV justified its compliance with the requirement by reiterating the submitted supporting documents, i.e. the copy of the Lease Agreement, photographs of the body plate and water truck together with the LTO OR/CR, showing the capacity of the water truck. The BAC-I resolved to reconsider. Based on RA 8794, the vehicle's capability to meet the required capacity can be determined from the water truck's number of axles, which are technical questions that can be addressed and verified during the post-qualification.

6. Almeria International Construction Corporation/ Foundation Specialist Inc (Joint Venture)

Decision: GRANTED

In the detailed bid evaluation, it was uncovered that the Certificate of Availability of Equipment under the Lease and Purchase Agreement was signed by the Bidder and not by the Lessor and the Vendor, respectively.

Based on the MR, the JV argued that it merely followed the prescribed format of the Statement of Availability of Key Personnel and Equipment (Annex "B") in the Bidding Documents, which specified the Authorized Representative of the bidder as the signatory. The BAC-I resolved to reconsider.

7. Frontnine Konstruct and Wismon Construction and Development Corporation (Joint Venture)

Decision: DENIED

In the detailed bid evaluation, the nominated personnel for Materials Engineer II did not meet the required minimum number of years: 5 years accreditation as Materials Engineer II and 3 years experience as Materials Engineer II.

Based on the Accreditation Identification No. 3479 submitted for Engr. Jose L. Icban, Jr., he was accredited as Materials Engineer II only on 11 April 2019 - or for a period of 2 years and 6 months only, thus failing to meet the required 5 years accreditation.







8. New San Jose Builders Inc and Tryst Builders Enterprises (Joint Venture)	Decision: GRANTED There was no project declared in the submitted Statement of On-Going Private and Government Contract of the New San Jose Builders, Inc. (NSJB). During the detailed bid evaluation, it was determined that the NSJB had 4 undeclared ongoing projects which were posted in their own website as ongoing projects. Based on the MR, the JV claimed that the ongoing projects identified from the website are owned by New San Jose Builders and were already cancelled as a result of the Covid-19 Pandemic.
9. Sta. Clara International Corporation	Decision: GRANTED In the detailed bid evaluation, the OR/CR of the pledged water truck, showed a net capacity of 12,500 kg or equivalent to 12,500L, which did not meet the required equipment capacity of 16,000L. Based on the MR, the LTO OR/CR only shows proof of ownership and that the net weight shown in the OR/CR does not necessarily refer to or correspond to the volumetric capacity.

WHEREAS, based on the decision of the BAC-I on the above MRs, the list of bidders as ranked in ascending order of their total calculated prices is as follows:

WHEREAS, consequent to the above results of the detailed bid evaluation, Finmat International Resources was declared as the bidder with the Lowest Calculated Bid for the Project, and was subjected to post-qualification on 25 to 29 November 2021. After the post-qualification, the BAC-I,









on 01 December 2021, declared Finmat International Resources as post-disqualified for the Project due to the following:

As per post-qualification visit/inspection, the body plate indicates 50-Ton capacity. However, the hook of the crane is only rated for 25 Tons as labeled; hence, the maximum lifting capacity is only 25 Tons. Additionally, only the OR/CR was validated as it is the only document submitted in the Bid Proposal for this Mobile Crane. The crane truck does not have a license plate when the TWG inspected the equipment. According to the Finmat representative, the registration of the Mobile Crane is still pending with the LTO for renewal. Non-Compliant as per BDS Clause 10.5 Requirement of 2 units 50-Ton Mobile Crane.

The set of equipment was not available for inspection during the post-qualification period indicated in the Notice of Post-qualification letter.

Detailed As-Built Bill of Quantities of Single Largest Completed Contract.	The submitted document was not an as-built BOQ but a Summary of Final Account and Variations Arising From Project Manager's Instruction. The sum of the items in the submitted Summary of Final Account (Php 738,655,138.91) does not equate to the total contract value at completion as declared in the Statement of SLCC (Php 2,165,248,108.55).

WHEREAS, the Joint Venture of Specified Contractors and Development Inc., Horamabi Builders, and A-Win Enterprise and Solutions Inc. was declared the bidder with the next/second LCB for the Project, subject to post-qualification pursuant to Section 34.6 of the Revised IRR of RA9184. Thereafter, the post-qualification on the said bidder commenced on 03 December 2021. After post-qualification, on 09 December 2021, the BAC-I declared the Joint Venture of Specified Contractors and Development Inc., Horamabi Builders, and A-Win Enterprise and Solutions Inc. as post-disqualified for the Project due to the following:

While the water truck has a volumetric capacity of 20 cubic meters or equivalent to 20,000L, as engraved on the body plate, the OR/CR of the equipment indicates its capacity to be 6,363 kg or 6,363L only.









We note that the bidder submitted a justification for the determination of the allowable load capacity of the water truck based on the chart provided under RA 8794 or the Anti-Overloading Law, arriving at 20,887kg or 20,887L.

However, it is no less than the Land Transportation Office itself, in its letter dated 10 November 2021 and received on 03 December 2021, which confirmed that the Net Capacity indicated in the Certificate of Registration is the appropriate detail that shows the capacity of a vehicle.

WHEREAS, the Joint Venture of Foundation Specialists Inc., and Almeria International Construction Corporation was declared as the next/third LCB for the Project, subject to post-qualification pursuant to Section 34.6 of the Revised IRR of RA9184. Thereafter, the post-qualification on the said bidder commenced on 10 December 2021.

WHEREAS, on 17 December 2021, the BAC-I deliberated the TWG Report on the results of post-qualification on the Joint Venture of Foundation Specialists Inc., and Almeria International Construction Corporation. The TWG report shows that, after careful examination, validation and verification of all the submitted eligibility, legal, technical and financial documents, the BAC-I TWG found the JV of FSI and AICC compliant with and responsive to the requirements under the bidding documents for the Project and RA 9184. The TWG, in its Post-Qualification Report, recommended to the BAC-I to declare the Joint Venture of Foundation Specialists Inc., and Almeria International Construction Corporation as the bidder with the Lowest Calculated and Responsive Bid (LCRB) for the Project.

WHEREAS, the JV of FSI and AICC is not included in the GPPB List of Blacklisted Constructors as of 17 December 2021.

WHEREAS, on 20 December 2021, the BAC-I deliberated on the requests for reconsideration from Finmat International Resources ("Finmat") and from the Joint Venture of Specified Contractors and Development Inc., Horamabi Builders, and A-Win Enterprise and Solutions Inc. ("JV of SCDI-Horamabi-Awin") The BAC-I has denied these requests, with the request for reconsideration of Finmat being filed out of time. The request for reconsideration of the JV of SCDI-Horamabi-AWin was likewise denied due to the affirmation from the Land Transportation Office that the Certificate of Registration's Net Capacity is the appropriate detail to show the carrying capacity of a vehicle. The JV's water truck was only capable of carrying 6,363 liters of water as shown in its Certificate of Registration.

NOW, THEREFORE, foregoing considered and after careful evaluation and thorough deliberation of the bids submitted for the Project, we, the Members of the BAC-I, hereby RESOLVE as it is hereby RESOLVED the following:









- To declare the Joint Venture of Foundation Specialists Inc., and Almeria International Construction Corporation (JV of FSI/AICC) as the bidder with the Lowest Calculated and Responsive Bid (LCRB) based on the BAC-I TWG post-qualification report on the JV of FSI/AICC.
- 2. To recommend to the Officer-in-Charge OPCEO, as duly authorized and delegated by the BCDA Board as the Head of Procuring Entity, the award of the contract to the JV of FSI/AICC for the Construction Of Various Structures And Facilities Within The 100-Hectare Area At Bataan Technology Park, Morong Bataan (Phase 1 Package 2), in the amount of Pesos: Two Billion Five Hundred Seventy-Nine Million, One Hundred Forty Thousand, SIx Hundred Three and 95/100 (Php2,579,140,603.95).
- 3. To recommend to the Officer-in-Charge OPCEO, as duly authorized and delegated by the HOPE, the issuance of the corresponding Notice of Award (NOA) to the JV of FSI/AICC, being the bidder with the LCRB.
