**Rebidding for the Supply, Delivery and Installation of Office and School Equipment  
for the NAS – Phase 1 at New Clark City.**

We are pleased to provide further clarifications on the following eligibility requirements for the **Rebidding for the Supply, Delivery and Installation of Office and School Equipment for the NAS – Phase 1 at New Clark City:**

Queries	Clarification
1. For the Smart LED TVs, is there a requirement for the year model of the TVs in the market?	Minimum year model is 2021.
2. For the Wireless Projector, is it necessary that the remote-control battery is AA?	Replaceable battery.
3. For the Infrared Thermal Scanner w/ Stand, K3, how will the Digital Display Accuracy of $\pm 0.2$ Degrees be checked?	The Product Brochure will be used to check the compliance, subject for verification during post qualification and inspection during the delivery of the product.
4. Please clarify the cost of bidding documents for this project.	Pursuant to Annex 8 of the RIRR of RA 9184, since the ABC for this project is <b>Php3,822,500.00</b> , the cost of its bidding documents is <b>Php5,000.00</b> .

Reminders	
Single Largest Completed Contract (SLCC)	The Bidder must have completed a single contract that is similar to the project, equivalent to at least fifty percent (50%) of the ABC; or at least two (2) similar completed contracts with the aggregate amount equivalent to at least fifty percent (50%) of the ABC and the largest of these similar contracts must be equivalent to at least half of the percentage (25%) of the ABC.  The similar contract shall have been completed within ten (10) years prior to the date of submission and receipt of bid. For this purpose, contracts similar to the Project shall be <b>Contracts for the Supply, Delivery and Installation of Office and School Equipment.</b>
Financial Component	Original of duly signed and accomplished Financial Bid Form; <u>and</u> Original of duly signed and accomplished <u>Price Schedule</u>  Note: The Bidder must submit cost breakdown ( <b>price for each line item</b> ) and the total amount should not exceed the Approved Budget for the Contract (ABC) for the Project
Product Brochure OR Manufacturer's Certificate	<b>It is required</b> that the Bidders submit <b>Product Brochures and/or other related documents</b> containing the description and specifications of each item to be offered and/ <b>OR Certificate from the Manufacturer</b> , certifying compliance in all the specifications of each item to be offered as part of their technical envelope during opening of bids.

Bidders may choose to attend Opening of Bids in person or online via zoom.

For those who are attending in person, the following guidelines must be followed:


- A maximum of two (2) persons per participating bidder are allowed to attend the Opening of Bids and will be required to follow the BCDA Health Protocol for Visitors;
- The representative is required to present his/her vaccination card before he/she can be allowed inside the BCDA office;
- Compliance to social distancing, wearing of face masks, and body temperature screening inside BCDA office must be observed; and
- Observers/representatives who show signs of COVID-19 related symptoms such as cough, flu, fever, high body temperature, and sneezing are advised not to proceed to the BCDA Office since they will not be allowed to enter the BCDA premises.
