This Bid Bulletin clarifies queries/questions raised during the Pre-Bid Conference and other matters pertaining to the above cited Consulting Services.

I. QUERIES/QUESTIONS BY THE PROSPECTIVE BIDDERS

Queries/Questions		Clarifications	
1.	On MIAA Land and Building Machineries and Equipment (BME), Pasay City, clarify whether the appraisal to be conducted is only limited to the Land and Building Machineries and Equipment which are attached to buildings. Are the buildings excluded in the appraisal?	Appraisal will cover the Market Rent of land and building, machineries and equipment. Buildings refer to the structures (NAIA Terminal III) which are housed within the 60-hectare MIAA area. Machineries and equipment are those which are attached to/integral to the operation of the building such as elevators, air conditioning units, luggage conveyor, water pump, and the like). Map showing the perimeter of the property which includes Lots 13A and 14 is attached herewith.	
2.	Are all the buildings in MIAA (i.e. Terminals 1, 2, 3 and 4) part of the appraisal?	Same answer to Question no. 1	
3.	The appraisal requirement for the MIAA Land should include its Market Value.	The Market Value shall also be included as basis for the Market Rent.	
4.	Is this a reappraisal of the properties indicated in the Terms of Reference (TOR)?	Some of the properties indicated in the Terms of Reference were previously appraised (i.e., 2 or 3 years ago). However, there are new properties that will be appraised for the first time.

5. On Metro Manila Subway Project (MMSP) affected lots, what documents will be provided to the bidders with respect to the inventory of the machineries and equipment? Will it be limited to the machineries and equipment attached to the building or even the machineries and equipment that are not attached to the building?

The MMSP is still in the planning stage at present. The plans will be provided to the winning bidder.

In the plan, DOTr included areas for temporary and permanent facilities both above ground and below ground. These **planned facilities** are to be included in the appraisal of the Consultant. The plan does not include an inventory of machineries and equipment.

6. On Industrial Estate # 1 (Northern) and Industrial Estate #3 (Southern) for New Clark City Properties, what do we expect from the "as-is-where-is" condition? Are we pertaining only to any informal settlers or are there certain legal matters that we have to be ready with?

Yes, the term "as-is-where-is" alludes to the fact that there may be informal settlers and farmers occupying/using the property.

a. General Notes/Reminders

- 1. All data on the forms shall be correct and consistent.
- 2. All forms should be duly signed by the Authorized Signatory of the Firm/Entity/Joint Venture or Consortium (in case of JV/Consortium).
- 3. The Annex D (Omnibus Sworn Statement), Annex F (CV for Proposed Professional Staff), Annex K (Undertaking), and Annex M (Bid Securing Declaration Form) should be notarized.
- 4. The CVs of all the nominated key personnel should be supported with valid licenses/professional registrations, certificates of training attended, diplomas, work experiences and other supporting documents relative to credentials of the proposed professional staff.
- 5. For expired licenses, copy of the expired license, proof of application and payment for renewal should be included.
- 6. Only contracts that are supported with proofs shall be considered for evaluation, such as:
 - a. Certificate of Completion or Acceptance or Valid proof of final payment issued by the client in case of completed contracts.
 - b. Notice of Award, Notice to Proceed or signed contracts issued by the client for ongoing contracts and for contracts awarded but not yet started.
- 7. Only trainings that are supported with proofs shall be considered for evaluation.
