## PROCUREMENT OF CONSULTING SERVICES FOR THE WEB-BASED **QUAD-MEDIA MONITORING**

(Negotiated Procurement through Small Value Procurement)

## **RESOLUTION NO. 2022-012**

WHEREAS, the Bases Conversion and Development Authority (BCDA) is a government instrumentality vested with corporate powers under Republic Act (RA) No. 7227, as amended, mandated to transform and develop former military bases and properties into premier centers of economic growth. BCDA is committed to fulfill its mandate to its stakeholders and beneficiaries, particularly to its major stakeholder, the Armed Forces of the Philippines (AFP);

WHEREAS, the objectives of BCDA's Consulting Services for Web-based Quad-Media Monitoring are:

- a. To provide a cost-effective and more efficient media monitoring service to BCDA by outsourcing the media monitoring service to a highly qualified consultant;
- b. To make use of web-based monitoring system as a management tool that is accessible to BCDA decision-makers anytime, anywhere to aid in the decision-making process regarding crucial issues of public concern affecting BCDA; and,
- c. To provide timely access to BCDA-related news found in quad-media (print, radio, TV, and social media), including online news.

WHEREAS, the President and CEO of BCDA approved the memorandum of the Public Affairs Department (PAD) dated 17 October 2022 on the procurement of the Consulting Services for Web-based Quad-Media Monitoring, through Negotiated Procurement under Section 53.9 Small Value Procurement of the 2016 Revised Implementing Rules Regulations (RIRR) of R.A. No. 9184 with an Approved Budget of the Contract (ABC) of Pesos: Five Hundred Thousand and 00/100 (PhP 500,000.00), inclusive of all applicable government taxes and fees;

WHEREAS, in its memorandum to BAC-C dated 24 October 2022, the PAD requested the BAC-C to delegate the procurement of the aforementioned Consulting Services to PAD being the end-user department, subject to compliance with Section 53.9 of the 2016 RIRR of RA No. 9184;

WHEREAS, Section 53 of the 2016 RIRR of R.A. No. 9184 provides that the Negotiated Procurement is a method of procurement of Goods, Infrastructure Projects and Consulting Services, whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant in any of the following cases:

53.9. Small Value Procurement. Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR: xxx.

**WHEREAS,** Section V(D)(8)(a) of Annex H of 2016 RIRR of R.A. No. 9184 defines Small Value Procurement as the procurement of (a) goods not covered by Shopping under Section 52 of the IRR of RA 9184, (b) infrastructure projects, and (c) consulting services, where the amount involved does not exceed the following threshold:

i. For NGAs, GOCCs, GFIs, SUCs, and Autonomous Regional Government, One Million Pesos (P1,000,000)

**WHEREAS,** Section IV (J) – Delegation of Authority under Annex H of 2016 RIRR of R.A. No. 9184 provides that,

The conduct of Shopping and Negotiated Procurement under Emergency Cases, Small Value Procurement and Lease of Real Property and Venue may be delegated to the End-user unit or any other appropriate bureau, committee, or support unit duly authorized by the BAC through a Resolution approved by the HoPE.

**NOW, THEREFORE**, foregoing considered, We, the Members of the Bids and Awards Committee for Consulting Services (BAC-C), hereby RESOLVE as it is hereby RESOLVED to recommend the following:

- 1. To proceed with the procurement of Consulting Services for Web-based Quad-Media Monitoring through Negotiated Procurement Small Value Procurement under Section 53 of the 2016 RIRR of R.A. No. 9184, specifically Section 53.9;
- 2. To delegate to the Public Affairs Department as the end-user unit the authority to proceed with the conduct of procurement of the said Consulting Services, pursuant to Section IV (J) Delegation of Authority under Annex H of the 2016 RIRR of R.A. No. 9184;
- 3. To direct the end-user unit to request for the issuance of the Certificate of Availability of Funds (CAF) for the procurement prior to the award of the contract;
- 4. To require the end-user to submit and/or present a preliminary report to the BAC-C for its information and comments prior to the submission of its report on the recommendation of the award of contract to the Head of the Procuring Entity (HoPE);

- 5. To require the end-user to submit its report on the recommendation of the award of contract with all the supporting documents to the HoPE, through BAC-C, pursuant to Section IV (J) Delegation of Authority under Annex H of the 2016 RIRR of R.A. No. 9184:
- 6. To require the end-user to ensure that the posting of the Notice of Award, Contract, and Notice to Proceed pursuant to Annex H of the 2016 RIRR of R.A. No. 9184 are complied with; and
- 7. To direct the end-user unit to report to the BAC-C the results of the procurement process within ten (10) calendar days in the event that the procurement of said consulting services fails.
