## REBIDDING OF CATERING SERVICES FOR BCDA BOARD MEETINGS, COMMITTEE MEETINGS AND BOARD-RELATED ACTIVITIES FOR 2018

## RESOLUTION OF AWARD (RESO NO. BG-2018-017)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA) has put on bid the REBIDDING OF CATERING SERVICES FOR BCDA BOARD MEETINGS, COMMITTEE MEETINGS AND BOARD-RELATED ACTIVITIES FOR 2018 with an Approved Budget for the Contract (ABC) of One Million Two Hundred Forty-Two Thousand Six Hundred Pesos (Php1,242,600.00), inclusive of all applicable taxes and fees.

WHEREAS, the BAC for Goods, through its Secretariat, advertised the Invitation to Bid on 08 June 2018 in the following:

- a) DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b) BCDA Website; and
- c) In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to said advertisements, two (2) companies, FUNMANIA, INC. (FunMania) and ANGLO ARCHERS ASSETS CORP. (Anglo Archers) bought the bid documents.

WHEREAS, on 02 July 2018, on the scheduled Opening of Bids, the BAC for Goods received two (2) proposals from FunMania and Anglo Archers respectively. During this event, FunMania, having submitted the required eligibility documents was found eligible, thus, its financial proposal was opened.


WHEREAS, Anglo Archers was found ineligible for failure to include all its on-going government and/or private contracts in Form SF-GOOD-13a: Statement/List of all on-going and completed government and private contracts, similar in nature to the contract/project subject of the bidding at hand, within at least the past two (2) years (April 2016 to April 2018), in accordance with Sec. 23, Rule VIII of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184. Thus, its financial proposal was not opened.

WHEREAS, FunMania submitted its bid in the amount of One Million One Hundred Fifty-One Thousand and Forty Pesos & 00/100 (Php1,151,040.00), inclusive of all applicable taxes and fees. The Abstract of Bids is hereby attached as Annex "A".

WHEREAS, on separate dates, 09 July 2018 and 13 July 2018, the Technical Working Group (TWG) conducted post-qualification evaluation of FunMania to determine whether it is compliant with, and is responsive to the requirements and conditions specified in the Bidding Documents.

**WHEREAS**, upon post-qualification conducted by the TWG and after careful examination, validation and verification of all the eligibility, technical and financial documents submitted by FunMania, its bid has been found Complying and Responsive. *The Post-Qualification Report is hereby attached as Annex* "B".

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

- 1. To declare FUNMANIA, INC. as the bidder with the Single Calculated and Responsive Bid for the REBIDDING OF CATERING SERVICES FOR BCDA BOARD MEETINGS, COMMITTEE MEETINGS AND BOARD-RELATED ACTIVITIES FOR 2018;
- 2. To award the Contract to FUNMANIA, INC. in the amount of One Million One Hundred Fifty-One Thousand and Forty Pesos & 00/100 (Php1,151,040.00), inclusive of all applicable taxes and fees;
- 3. To issue the Notice of Award to FUNMANIA, INC. (copy attached); and,
- 4. To direct the Office of the Corporate Board Secretariat, being the end-user unit, to furnish the BAC for Goods copies of the duly conformed Notice of Award, Notice to Proceed and the duly executed agreement/contract.
